PLACING OF NEW SHARES UNDER GENERAL MANDATE

On 7 January 2010, the Company has entered into the Subscription Agreements with the Subscribers for the subscription of an aggregate 200,000,000 new Shares for an aggregate consideration of HK\$20,600,000 at the Subscription Price of HK\$0.103 per Subscription Share.

The Subscription Shares of 200,000,000 new Shares represent approximately 8.66% of the existing issued share capital of the Company and approximately 7.97% of its enlarged share capital. The Subscription Shares will be issued under the General Mandate and will rank equally with the existing Shares.

Completion of the Subscription pursuant to the Subscription Agreements is conditional upon, inter alia, the Listing Committee agreeing to grant a listing of and permission to deal in the Subscription Shares.

SUBSCRIPTION AGREEMENTS DATED 7 JANUARY 2010

Parties:

Issuer : The Company

Subscribers : Not less than six Subscribers (of which some of them are existing Shareholders holding an aggregate of approximately 1.01% of the existing issued share capital of the Company; and one of them holds 16,500,000 Share Options, the underlying shares in the Share Options represent approximately 0.71% of the existing issued share capital of the Company), being individuals, institutional or other professional investors, and who and whose ultimate beneficial owners (if any) are third parties independent of the Company and its connected persons (as defined in the Listing Rules). It is expected that none of the Subscribers will become a substantial shareholder (as defined in the Listing Rules) of the Company immediately upon completion of the Subscription.

Number of Subscription Shares subscribed for:

200,000,000 new Shares at an aggregate nominal value of HK\$20,600,000, representing approximately 8.66% of the existing issued share capital of the Company and approximately 7.97% of its issued share capital as enlarged by the Subscription.

Subscription Price:

HK\$0.103 per Subscription Share, representing:

- (a) a discount of approximately 16.26% to the closing price of HK\$0.123 per Share as quoted at 4:00 p.m. on the Last Trading Day on the Stock Exchange;
- (b) a discount of approximately 19.53% to the average closing price of approximately HK\$0.128 per Share as quoted on the Stock Exchange for the last five trading days immediately prior to the Last Trading Day; and
- (c) a discount of approximately 16.94% to the average closing price of approximately HK\$0.124 per Share as quoted on the Stock Exchange from 22 December 2009 to 6 January 2010, both dates inclusive, being the last ten trading days immediately prior to the Last Trading Day.

Based on an estimated expenses of approximately HK\$50,000 for the Subscription, the Company will be able to raise HK\$20.60 million gross proceeds and approximately HK\$20.55 million net proceeds from the Subscription. On this basis, the net issue price per Subscription Share is approximately HK\$0.103. The Subscription Price is determined at arm's length basis and the Directors consider that the terms of the Subscription Agreements are fair and reasonable and are in the interest of the Company. The Subscription Price of the Subscription Shares will be paid to the Company at the earlier of (i) 14 January 2010 and (ii) the date of allotment of the Subscription Shares.

Mandate to issue the Subscription Shares:

The Subscription Shares will be issued under the General Mandate granted to the Directors pursuant to the resolutions of the Shareholders passed at the annual general meeting of the Company held on 30 June 2009.

Ranking:

The Subscription Shares, when issued and fully paid, will rank pari passu among themselves and with all other Shares presently in issue and at the time of issue and allotment of the Subscription Shares.

Condition of the Subscription:

The Subscription is conditional on the granting of a listing of and permission to deal in the Subscription Shares by the Listing Committee of the Stock Exchange.

If the condition is not fulfilled on or before 29 January 2010 (or such other date as the parties may mutually agree) the Subscription Agreements shall lapse.

Completion of Subscription:

The Business Day immediately after all conditions of the Subscription has been fulfilled (or such other date as the parties may agree).

APPLICATION FOR LISTING

Application will be made by the Company to the Stock Exchange for the grant of listing of and permission to deal in the Subscription Shares.

REASONS FOR THE SUBSCRIPTION AND USE OF PROCEEDS

The Group has been suffering losses in the previous financial periods. For the period ended 30 June 2009 and year ended 31 December 2008, the Group's loss for the period/year amounted to US\$17,385,316 (equivalent to approximately HK\$134,736,199) and US\$75,093,827 (equivalent to approximately HK\$581,977,159) respectively. As at 30 June 2009, the Group had bank balances and cash of US\$2,760,577 (equivalent to approximately HK\$21,394,472).

The Directors consider that it is in the interests of the Company to raise capital from the equity market in order to maintain the cashflow position of the Group and to enhance the capital base of the Company. The Company will use the estimated net proceeds of the Subscription as general working capital. The Directors (including the independent non-executive Directors) consider the terms of the Subscription Agreements and the Subscription Agreements to be fair and reasonable and are in the best interests of the Company, as far as the Shareholders are concerned.

The Company considers that the Subscription is a preferred method of fund raising as compared with other equity fund raising exercises based on time and costs involved.

EFFECT OF THE SUBSCRIPTION ON SHAREHOLDING STRUCTURE

Assuming that there will be no change in the shareholding structure of the Company immediately before completion of the Subscription, the shareholding structure of the Company immediately before and after the Subscription will be as follows:
