The total consideration for the above acquisition is US\$68,000,000 out of which US\$38,000,000 will be satisfied by the issue of the Convertible Notes. Upon full conversion of the Convertible Notes, a maximum of 1,965,866,667 Conversion Shares (subject to adjustment) will be issued.
