At the EGM convened on 23 January 2015, the Shareholders adopted resolutions approving the Acquisition, subject to certain conditions.</p> <p>The total consideration for the Acquisition is US\$77,480,000 out of which US\$38,000,000 will be satisfied by the issue of the Convertible Notes and US\$5,300,000 will be satisfied by the issue of the LA Convertible Notes at the initial Conversion Prices of HK\$0.10 and HK\$0.473 per Conversion Share, respectively (subject to adjustment).
