DELAY IN DESPATCH OF CIRCULAR

Reference is made to the announcement (the “**Announcement**”) of Stelux Holdings International Limited (the “**Company**”) dated 26 January 2018 in relation to, among others, the Disposal, and the Company’s announcement dated 20 February 2018 (the “**Second Announcement**”) in relation to the delay in despatch of the Circular (as defined below). Unless otherwise specified, capitalised terms used in this announcement shall bear the same meanings as those used in the Announcement.
