# GENERAL MANDATES TO REPURCHASE SHARES AND TO ISSUE NEW SHARES RE-ELECTION OF DIRECTORS AND NOTICE OF ANNUAL GENERAL MEETING

# 1. INTRODUCTION

The purpose of this circular is to provide you with information regarding resolutions to be proposed at the Annual General Meeting of the Company to be held on Friday, 9th August, 2013. These include (i) the ordinary resolutions granting the Directors general mandates to issue and repurchase Shares and extension of general mandates to issue additional Shares; and (ii) the ordinary resolutions proposing re-election of Directors who are due to retire at the Annual General Meeting.

# 2. GENERAL MANDATES TO REPURCHASE SHARES AND TO ISSUE NEW SHARES

At the Annual General Meeting of the Company held on 23rd August, 2012, ordinary resolutions were passed giving general mandates to the Directors (i) to repurchase Shares on the Stock Exchange of up to 10 per cent of the issued share capital of the Company as at 23rd August, 2012 and (ii) to allot, issue and otherwise deal with additional Shares up to a limit equal to (a) 190,268,004 shares, representing 20 per cent of the Shares in issue as at 23rd August, 2012 plus (b) the nominal amount of any Shares repurchased by the Company.

At the Annual General Meeting of the Company to be held on 9th August, 2013, ordinary resolutions will be passed giving general mandates to the Directors (i) to repurchase Shares on the Stock Exchange of up to 10 per cent of the issued share capital of the Company as at 9th August, 2013 and (ii) to allot, issue and otherwise deal with additional Shares up to a limit equal to (a) 209,294,805 shares, representing 20 per cent of the Shares in issue as at 9th August, 2013 plus (b) the nominal amount of any Shares repurchased by the Company.

Under the terms of the Rules Governing the Listing of Securities on the Stock Exchange, these general mandates will lapse at the conclusion of the Annual General Meeting of the Company for 2013 unless renewed at that Meeting. Ordinary resolutions will be proposed to renew the Repurchase Mandate and the mandate to issue Shares and the explanatory statement required by the Listing Rules to be sent to the Shareholders in connection with the proposed Repurchase Mandate is set out in Appendix I to this circular.

#### 3. RE-ELECTION OF DIRECTORS

In accordance with Bye-law 110(A) of the Company's Bye-laws, Mr. Nelson Wu Chun Sang ("Mr. Wu") and Dr. Agnes Kwong Yi Hang will retire by rotation at the forthcoming Annual General Meeting and, being eligible, offer themselves for re-election.

Mr. Wu, aged 56, was appointed an independent non-executive Director in 2004 and by the forthcoming Annual General Meeting will have served for 9 years. Mr. Wu has confirmed his independence as regards each of the factors referred to in Rule 3.13(1) to (8) of the Listing Rules; he does not have any past or present financial or other interest in the business of the Company or its subsidiaries or any connection with any connected person (as defined under the Listing Rules); and there are no other factors that may affect his independence. Therefore, the Board has no reason to believe that Mr. Wu is not independent and proposes his re-election as an independent non-executive Director.

In accordance with Bye-law 101 of the Company's Bye-laws, Mr. Wallace Kwan Chi Kin, Ms. Mary Ma Xuezheng and Mr. Alex Wong Yu Tsang having been appointed as Directors, shall hold office only until the forthcoming Annual General Meeting and, being eligible, offer themselves for re-election.

The particulars of those Directors offering themselves for re-election which are required to be disclosed by the Listing Rules are set out in Appendix II to this circular.

#### **General Information**

The ordinary resolutions mentioned above are set out in full in the notice of Annual General Meeting set out on pages 14 to 18 of this circular. Your right to demand a poll, and the procedures for demanding a poll on the proposed resolutions at the Annual General Meeting are set out in Appendix III to this circular.

#### 4. CLOSURE OF REGISTER OF MEMBERS

In order to determine entitlement of Shareholders to the right to attend and vote at the Annual General Meeting (or any adjournment thereof), the Register will be closed from Tuesday, 6th August, 2013 to Friday, 9th August, 2013, both days inclusive, during which period no share transfer will be effected. All transfers accompanied by the relevant share certificates must be lodged with the Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, at 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, for registration no later than 4:30 p.m. on Monday, 5th August, 2013.

In order to determine Shareholders who qualify for the proposed final dividend and special dividend, the Register will be closed from Thursday, 15th August, 2013 to Monday, 19th August, 2013, both days inclusive, during which period no share transfer will be effected. All transfers accompanied by the relevant share certificates must be lodged with the Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, for registration no later than 4:30 p.m. on Wednesday, 14th August, 2013.

# 5. ANNUAL REPORT AND ANNUAL GENERAL MEETING

A copy of the annual report of the Company for the year ended 31st March, 2013 is enclosed for your review.

The notice convening the Annual General Meeting to be held at Unit 1501, 15/F, Stelux House, 698 Prince Edward Road East, San Po Kong, Kowloon, Hong Kong on Friday, 9th August, 2013 at 11:30 a.m. is set out on pages 14 to 18. At the Annual General Meeting, ordinary businesses will be considered including, ordinary resolutions will be proposed to re-elect the retiring Directors; to renew the general mandate for the repurchase of Shares; and to renew the general mandate to allot, issue and otherwise deal with additional Shares.

A form of proxy for use at the Annual General Meeting is enclosed. Whether or not you are able to attend the Annual General Meeting, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and return it to the Company's registrar in Hong Kong at 17M Floor, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible and in any event, so as to be received not less than 48 hours before the time appointed for the holding of the Annual General Meeting. Completion and delivery of the form of proxy will not prevent you from attending and voting at the Annual General Meeting (or any adjournment thereof) if you so wish.

At the Annual General Meeting, the Chairman of the Meeting will exercise his power under Bye-law 78 of the Bye-laws to put each of the resolutions set out in the notice of Annual General Meeting to the vote by way of poll.

#### 6. RECOMMENDATION

The Directors consider that the ordinary resolutions granting the Directors general mandates to issue and repurchase Shares and extension of general mandates to issue additional Shares; and proposing re-election of Directors who are due to retire at the Annual General Meeting are all in the best interests of the Company and the Shareholders. Accordingly, the Directors recommend you to vote in favour of such resolutions at the Annual General Meeting.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide information to you with regard to the Repurchase Mandate.

#### 1. THE LISTING RULES

The Listing Rules provide that all proposed repurchases of shares by a company with a primary listing on the Stock Exchange must be approved in advance by an ordinary resolution of Shareholders, either by way of general mandate or by specific approval of a particular transaction.

#### 2. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company, which are fully-paid up, comprised 1,046,474,025 Shares of the Company. Subject to the passing of the necessary ordinary resolutions and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, exercise in full of the Repurchase Mandate could accordingly result in up to 104,647,402 Shares, representing 10 per cent of the issued share capital of the Company, being repurchased by the Company during the course of the period prior to the next Annual General Meeting.

#### 3. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and its Shareholders to have a general authority from Shareholders to enable the Directors to repurchase Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and its Shareholders.

# 4. FUNDING OF REPURCHASES

Repurchases of Shares will be funded entirely from the Company's available cash flow or working capital facilities, which will be funds legally available for the purchase in accordance with the Company's Memorandum of Association and Bye-laws and the applicable laws of Bermuda. There might be a material adverse effect on the working capital or gearing position of the Company upon the full exercise of the Repurchase Mandate at any time during the proposed purchase period when compared with the working capital and gearing position disclosed in the audited accounts contained in the annual report for the year ended 31st March, 2013. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

#### 5. GENERAL

None of the Directors or, to the best of their knowledge having made all reasonable enquiries, any of their associates as defined in the Listing Rules, have any present intention to sell any Shares to the Company if the Repurchase Mandate is approved by Shareholders. No connected person (as defined in the Listing Rules) has notified the Company that he has a present intention to sell Shares to the Company, or has undertaken not to do so, if the Repurchase Mandate is approved by Shareholders.

The Directors have undertaken to the Stock Exchange that, they will only exercise the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of Bermuda. The Directors are not aware of any consequences which could arise under the Takeovers Code as a consequence of any repurchases pursuant to the Repurchase Mandate. However, if as a result of a share repurchase a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a shareholder or a group of shareholders acting in concert could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. As at the Latest Practicable Date, Mr. Chumphol Kanjanapas held 605,206,992 Shares representing approximately 57.83% of the total issued share capital of the Company. Assuming his shareholding interest remains unchanged, upon the exercise of the Repurchase Mandate in full by the Directors, Mr. Chumphol Kanjanapas would be interested in approximately 64.26%. Such increase may give rise to an obligation to make a mandatory general offer under Rule 26 of the Takeovers Code. The Directors have no present intention to exercise the power of the Company to repurchase Shares to such an extent as would trigger the Takeovers Code and result in the number of Shares in public hands falling below 25 per cent.

He is a member of the Company's Remuneration, Nomination and Corporate Governance Committees and also the Chairman of the Company's Audit Committee.

Save for the relationship arising from Mr. Wu's position as an independent non-executive Director of the Company, Mr. Wu is not related to any other Directors, senior management or substantial or controlling shareholders of the Company. He does not have any other directorships in listed companies other than the Company for the last 3 years.

Mr. Wu's proposed re-appointment as an independent non-executive Director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A), whichever is the earlier. Subject to approval by the Company's Shareholders at the forthcoming Annual General Meeting, Mr. Wu will be entitled to a director's fee of HK\$135,000.00 per annum. The basis of determination of Mr. Wu's director's fee is by reference to market terms, the qualifications and experience of Mr. Wu. Save for the director's fee, Mr. Wu was not entitled to any other emoluments for the financial year ended 31st March, 2013.

Dr. Agnes Kwong Yi Hang, aged 54, was appointed an independent non-executive Director. She is a director of Good Food Watch Limited and Health Wisdom Limited. Both of these companies are health consultancies. She holds a PhD in Molecular Immunology from the University of Hong Kong.

Save for the relationship arising from Dr. Kwong's position as an independent non-executive Director of the Company, Dr. Kwong is not related to any other Directors, senior management or substantial or controlling shareholders of the Company. She does not have any other directorships in listed companies other than the Company for the last 3 years.

Dr. Kwong's proposed re-appointment as an independent non-executive Director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A), whichever is the earlier. Subject to approval by the Company's Shareholders at the forthcoming Annual General Meeting, Dr. Kwong will be entitled to a director's fee of HK\$135,000.00 per annum. The basis of determination of Dr. Kwong's director's fee is by reference to market terms, the qualifications and experience of Dr. Kwong. Save for the director's fee, Dr. Kwong was not entitled to any other emoluments for the financial year ended 31st March, 2013.

Mr. Wallace Kwan Chi Kin, aged 43, joined the Stelux Group in November 2011 as Group Finance Director and was appointed an executive Director and Chief Financial Officer of the Company on 2nd July, 2013. Mr. Kwan holds a Bachelor of Social Science Degree from The Chinese University of Hong Kong. He also holds a Master of Business Administration Degree from the University of Manchester and a Master of Laws in Corporate & Financial Law from The University of Hong Kong. He is a member of the Hong Kong Institute of Certified Public Accountants and also a fellow of the Association of Chartered Certified Accountants. Mr. Kwan has over 20 years of experience in financial management having worked at an international audit firm and listed companies.

Save for the relationship arising from Mr. Kwan's position as an executive Director and Chief Financial Officer of the Company, Mr. Kwan is not related to any other Directors, senior management or substantial or controlling shareholders of the Company. He does not have any other directorships in listed companies other than the Company for the last 3 years.

Mr. Kwan's proposed re-appointment as an executive Director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A), whichever is the earlier. Subject to approval by the Company's Shareholders at the forthcoming Annual General Meeting, Mr. Kwan will be entitled to a director's fee of HK\$80,000.00 per annum. Mr. Kwan's yearly emoluments shall be approximately HK\$1,440,000 plus payment of a bonus pursuant to the Company's bonus scheme. The basis of determination of Mr. Kwan's yearly emoluments and director's fee are by reference to market terms and the qualifications and experience of Mr. Kwan.

Ms. Mary Ma Xuezheng, aged 61, was appointed non-executive Director on 18th December, 2012. She is a Managing Partner of Boyu Capital Advisory Co. Ltd. ("Boyu Capital"), the adviser to the investment fund which ultimately owns Sapphire Illuminatus Holdings Limited, a strategic investor in the Company. Prior to Boyu Capital, Ms. Ma was a Partner of TPG Capital and co-Chairman of TPG China where she primarily focused on investments in the Greater China region. Before joining TPG, Ms. Ma was a Senior Vice President and Chief Financial Officer of Lenovo Group Ltd., a company listed on the Hong Kong Stock Exchange. Ms. Ma has been a member of the Lenovo board since 1997 and currently serves as Non-Executive Vice Chairman, a role she has served since 2007. She is also an independent non-executive director of Standard Chartered Bank (Hong Kong) Limited, a non-executive director of Wumart Stores, Inc. and a non-executive director of Unilever N.V. and Unilever PLC. Between 2009 and 2011 Ms. Ma was a non-executive Director of Daphne International Holdings Ltd., a company listed on the Hong Kong Stock Exchange. Ms. Ma has been a member of the Listing Committee of the Hong Kong Stock Exchange since 2009 and has been a member of The Hong Kong Institute of Directors since 2000. Ms. Ma worked for The Chinese Academy of Sciences before Lenovo. Ms. Ma graduated from Capital Normal University.

Save for the relationship arising from Ms. Ma's position as a non-executive Director, Ms. Ma is not related to any other Directors, senior management or substantial or controlling shareholders of the Company. Save as disclosed above, she has not held any directorships in any other listed companies for the last 3 years.

Ms. Ma's proposed re-appointment as a non-executive Director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A), whichever is the earlier. Ms. Ma was not entitled to any remuneration or director's fees for the financial year ended 31st March, 2013.

Mr. Alex Wong Yu Tsang, aged 35, was appointed non-executive Director on 18th December, 2012. He is an Executive Director of Boyu Capital, the adviser to the investment fund which ultimately owns Sapphire Illuminatus Holdings Limited, a strategic investor in the Company. Prior to Boyu Capital, Mr. Wong was an Executive Director at Goldman Sachs' Principal Investment Area. Prior to this, Mr. Wong was a consultant in McKinsey & Company's Corporate Finance Practice. Mr. Wong holds a Bachelor of Business Administration degree (First class honours) from the Chinese University of Hong Kong.

Save for the relationship arising from Mr. Wong's position as a non-executive Director, Mr. Wong is not related to any other Directors, senior management or substantial or controlling shareholders of the Company. Save as disclosed above, he has not held any directorships in any other listed companies for the last 3 years.

Mr. Wong's proposed re-appointment as a non-executive Director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A), whichever is the earlier. The Company's Bye-laws 78, 79 and 80 set out the procedure by which Shareholders may demand a poll:

# 1. Bye-law 78

At any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is otherwise required to be taken under the Listing Rules or a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded:—

- (i) by the Chairman of the meeting; or
- (ii) by at least three members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy for the time being entitled to vote at the meeting; or
- (iii) by any member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or
- (iv) by a member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right.

Unless a poll be so demanded and not withdrawn, or is otherwise required to be taken under the Listing Rules, a declaration by the Chairman that a resolution has on a show of hands been carried or carried unanimously, or by a particular majority, or lost, and an entry to that effect in the book containing the minutes of the proceedings of the Company shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour or against such resolution.

# 2. Bye-law 79

If a poll is required or demanded as aforesaid, it shall (subject as provided in Bye-law 80) be taken in such manner (including the use of ballot or voting papers or tickets) and at such time and place, not being more than thirty days from the date of the meeting or adjourned meeting at which the poll was required or demanded, as the Chairman directs. No notice need be given of a poll not taken immediately. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was required or demanded.
