GENERAL MANDATES TO REPURCHASE SHARES AND TO ISSUE NEW SHARES

At the Annual General Meeting of the Company held on 6th September, 2007, ordinary resolutions were passed giving general mandates to the Directors (i) to repurchase shares of the Company on The Stock Exchange of Hong Kong Limited ("the Stock Exchange") of up to 10 per cent of the issued share capital of the Company as at 6th September, 2007 and (ii) to allot, issue and otherwise deal with additional shares of the Company up to a limit equal to (a) 20 per cent of the shares of the Company in issue as at 6th September, 2007 plus (b) the nominal amount of any shares repurchased by the Company.

At the Annual General Meeting of the Company to be held on 8th September, 2008, ordinary resolutions will be passed giving general mandates to the Directors (i) to repurchase shares of the Company on The Stock Exchange of Hong Kong Limited ("the Stock Exchange") of up to 10 per cent of the issued share capital of the Company as at 8th September, 2008 and (ii) to allot, issue and otherwise deal with additional shares of the Company up to a limit equal to (a) 190,268,004 shares, representing 20 per cent of the shares of the Company in issue as at 8th September, 2008 plus (b) the nominal amount of any shares repurchased by the Company.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide information to you with regard to the Repurchase Mandate.

1. THE LISTING RULES

The Listing Rules provide that all proposed repurchases of shares by a company with a primary listing on the Stock Exchange must be approved in advance by an ordinary resolution of shareholders, either by way of general mandate or by specific approval of a particular transaction.

2. SHARE CAPITAL

As at 25th July, 2008 (the latest practicable date prior to the printing of this circular) ("Latest Practicable Date"), the issued share capital of the Company comprised 951,340,023 shares of HK\$0.10 each of the Company ("Shares"). Subject to the passing of the necessary ordinary resolutions and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, exercise in full of the Repurchase Mandate could accordingly result in up to 95,134,002 Shares, representing 10 per cent of the issued share capital of the Company, being repurchased by the Company during the course of the period prior to the next Annual General Meeting.

3. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and its shareholders to have a general authority from shareholders to enable the Directors to repurchase Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and its shareholders.

4. FUNDING OF REPURCHASES

Repurchases of Shares will be funded entirely from the Company's available cash flow or working capital facilities, which will be funds legally available for the purchase in accordance with the Company's Memorandum of Association and Bye-Laws and the applicable laws of Bermuda. There might be a material adverse effect on the working capital or gearing position of the Company upon the full exercise of the Repurchase Mandate at any time during the proposed purchase period when compared with the working capital and gearing position disclosed in the audited accounts contained in the annual report for the year ended 31st March, 2008. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. GENERAL

None of the Directors or, to the best of their knowledge having made all reasonable enquiries, any of their associates as defined in the Listing Rules, have any present intention to sell any Shares to the Company if the Repurchase Mandate is approved by shareholders. No connected person (as defined in the Listing Rules) has notified the Company that he has a present intention to sell Shares to the Company, or has undertaken not to do so, if the Repurchase Mandate is approved by shareholders.

The Directors have undertaken to the Stock Exchange that, they will only exercise the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of Bermuda. The Directors are not aware of any consequences which could arise under the Hong Kong Code on Takeovers and Mergers (the "Takeover Code") as a consequence of any repurchases pursuant to the Repurchase Mandate. However, if as a result of a share repurchase a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeover Code. Accordingly, a shareholder or a group of shareholders acting in concert could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeover Code. As at the Latest Practicable Date, Yee Hing Company Limited and its subsidiaries ("Yee Hing Group") held 300,069,959 Shares representing approximately 31.54% of the total issued share capital of the Company. Assuming the shareholding interests of Yee Hing Group remain unchanged, upon the exercise of the Repurchase Mandate in full by the Directors, Yee Hing Group would be interested in approximately 35.05%. Such increase may give rise to an obligation to make a mandatory general offer under Rule 26 of the Takeovers Code. Moreover, the Directors have no present intention to exercise the power of the Company to repurchase Shares to such an extent as would trigger the Takeover Code and result in the number of Shares in public hands falling below 25 per cent.

Prof. Wu's proposed re-appointment as an independent non-executive Director will be for a term of 3 years subject to retirement by rotation according to the Company's Bye-law 110(A), whichever is the earlier. Subject to approval by the Company's shareholders at the forthcoming Annual General Meeting, Prof. Wu will be entitled to a director's fee of HK\$120,000.00 per annum. The basis of determination of Prof. Wu's director's fee is by reference to market terms, the qualifications and experience of Prof. Wu. Save for the director's fee, Prof. Wu was not entitled to any other emoluments for the financial year ended 31st March 2008.

Dr. Agnes Kwong Yi Hang, aged 49, is a director of Pallavi International Limited (Hong Kong), a health consultancy. She holds a PhD in Molecular Immunology from the University of Hong Kong.

Dr. Kwong is the daughter of Mr. Kwong Yiu Chung, a former independent non-executive director of the Company.

Subject to approval by the Company's shareholders at the forthcoming Annual General Meeting, Dr. Kwong will be entitled to a director's fee of HK\$120,000.00 per annum. The basis of determination of Dr. Kwong's director's fee is by reference to market terms, the qualifications and experience of Dr. Kwong. Save for the director's fee, Dr. Kwong was not entitled to any other emoluments for the financial year ended 31st March 2008.

Neither of Prof. Lawrence Wu Chi Man, Dr. Agnes Kwong Yi Hang has a service contract with the Company which is not determinable by the employer within one year without payment of compensation (other than statutory compensation).

In respect of Prof. Lawrence Wu Chi Man and Dr. Agnes Kwong Yi Hang, there is no other information to be disclosed or any other matters that need to be brought, to the attention of the Company's shareholders pursuant to the requirements of Rules 13.51(2)(h) to (w).

The Company's Bye-laws 78, 79 and 80 set out the procedure by which shareholders may demand a poll:

1. Bye-law 78

At any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded:
