- (i) A substantial fair value loss on the Group's overseas listed equity securities was recognized for the year ended 31 December 2022, whereas a fair value gain of approximately HK\$87.7 million was recognized for the last corresponding year; and
- (ii) A fair value loss on the Group's investment properties as well as a write-down of carrying amount of the Group's stock of properties ("Write-down of the Stock of Properties") were recognized for the year ended 31 December 2022, while a fair value gain on the Group's investment properties and a reversal of Write-down of the Stock of Properties in the aggregate amount of approximately HK\$8.6 million were recognized for the last corresponding year.

The aforesaid fair value losses on the Group's overseas listed equity securities and investment properties as well as Write-down of the Stock of Properties are all unrealized in nature and are non-cash items which will not affect the cash flows of the Group.

The Company is still in the process of finalizing the final results of the Group for the year ended 31 December 2022.
