1. INTRODUCTION

At the AGM to be held at Kennedy Room, Level 7, Conrad Hong Kong, Pacific Place, 88 Queensway, Hong Kong on Wednesday, 5 June 2013 at 2:30 p.m., the notice of which is contained in this circular, the following resolutions shall be proposed:

- (a) ordinary resolutions relating to re-election of retiring Directors;
- (b) ordinary resolution relating to granting of the Repurchase Mandate; and
- (c) ordinary resolutions relating to granting of the Share Issue Mandate.

LETTER FROM THE BOARD

The purpose of this circular is to provide you with further information to make an informed decision on whether to vote for or against the above proposed resolutions including the details of retiring Directors proposed to be re-elected at the AGM; the explanatory statement relating to Repurchase Mandate in compliance with the Listing Rules; and the Notice of the AGM as set out in Appendices I to III to this circular respectively.

2. PROPOSED RE-ELECTION OF RETIRING DIRECTORS

In accordance with bye-law 87 of the Bye-laws, Mr. Yeung Hoi Sing, Sonny and Ms. Yeung Mo Sheung, Ann shall retire by rotation and, being eligible, will offer themselves for re-election at the AGM.

On 27 March 2013, the Nomination Committee nominated, and the Board recommended Mr. Yeung and Ms. Ann Yeung to stand for re-election as Directors at the AGM. As a good corporate governance practice, both Mr. Yeung and Ms. Ann Yeung abstained from voting on their nominations at the meeting of the Board.

The Nomination Committee has assessed and reviewed the individual Director's annual confirmation of independence based on the independence criteria as set out in Rule 3.13 of the Listing Rules on 21 December 2012, and affirmed that all independent non-executive Directors including, Ms. Ann Yeung, remained independent.

Ms. Ann Yeung has served the Group for more than 9 years. As independent non-executive Director with extensive experience and knowledge in legal aspects and in-depth understanding of the Group's operations and businesses, Ms. Ann Yeung has expressed objective views and given independent guidance to the Board over the years, and she continues demonstrating a firm commitment to her role. The Nomination Committee considers that the long service of Ms. Ann Yeung would not affect her exercise of independent judgement and is satisfied that Ms. Ann Yeung has the required character, integrity and experience to continue fulfilling the role of an independent non-executive Director. The Board therefore recommends the re-election of Ms. Ann Yeung as an independent non-executive Director.

The following are the details of the retiring Directors proposed to be re-elected at the AGM:

Mr. Yeung Hoi Sing, Sonny, aged 58, joined the Group in 2003. He is an executive Director and the Chairman of the Company as well as a director of the subsidiaries of the Company. He is presently the sole beneficial owner of Success Securities Limited, which is a licensed corporation under the SFO as well as a participant of the Stock Exchange, principally engaged in the provision of securities brokerage services. Mr. Yeung has certain private investments in property development businesses in Hong Kong, Macau and Canada. He is also a director of Silver Rich, being a substantial shareholder of the Company. Mr. Yeung is the uncle of Dr. Ma Ho Man, Hoffman, an executive Director and the Deputy Chairman of the Company.

As at the Latest Practicable Date, Mr. Yeung was deemed to have an interest in 2,346,557,462 Shares within the meaning of Part XV of the SFO.

Mr. Yeung has entered into a service contract with the Company without specific term of office, however, he is subject to retirement by rotation and re-election at annual general meeting of the Company in accordance with the Bye-laws. Mr. Yeung is entitled to an annual salary of HK\$12 as well as other benefits in kind, which are medical, accidental and business travel insurances. Save as disclosed above, he is not entitled to any other forms of benefits. Mr. Yeung considered that the level of his salary is currently in the interest of the Company and its Shareholders as a whole, and his remuneration package was approved by the Remuneration Committee.

She is currently an independent non-executive director of Hao Wen Holdings Limited and Merdeka Resources Holdings Limited, the issued shares of both companies are listed on the Growth Enterprise Market of the Stock Exchange.

Ms. Ann Yeung has entered into a service contract with the Company for a term of one year and she receives a director's fee of HK\$120,000 per annum under the service contract. Her remuneration is determined by the Board with reference to her responsibilities and prevailing market conditions.

APPENDIX II

EXPLANATORY STATEMENT RELATING TO REPURCHASE MANDATE

1. LISTING RULES RELATING TO THE REPURCHASES OF SECURITIES

In the event that the Proposed Acquisition is approved by the Shareholders (other than Maruhan Corporation and its associates who are required to abstain from voting under the Listing Rules) at the SGM and the Option Completion takes place prior to the AGM, the issued share capital of the Company will comprise 4,615,486,412 Shares. Subject to the passing of the proposed resolution for the approval of the Repurchase Mandate and on the basis that no further Shares (other than the Consideration Shares) are issued or repurchased by the Company prior to the AGM, the Company would be allowed under the Repurchase Mandate and on the basis that no further Shares (other than the Consideration Shares) are issued or repurchased by the Company prior to the AGM, the Company would be allowed under the Repurchase Mandate to repurchase up to a maximum of 461,548,641 Shares.

3. REASONS FOR REPURCHASES

The Directors believe that it may be to the benefit of the Company and its Shareholders for the Company to repurchase its Shares in certain circumstances. An exercise of the Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets value and/or earnings per Share. Therefore, the Directors are seeking the grant of a general mandate to repurchase Shares to give the Company the flexibility to do so if and when appropriate.

4. FUNDING OF REPURCHASES

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchase pursuant to the Repurchase Mandate in accordance with the Listing Rules, the applicable laws of Bermuda, the memorandum of association of the Company and the Bye-laws.

9. EFFECT OF THE TAKEOVERS CODE

If a Shareholder's proportionate interest in the voting rights of the Company increases on the Company exercising its powers to repurchase Shares pursuant to the Repurchase Mandate, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert, depending on the level of increase of the Shareholders' interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, Silver Rich held 2,346,557,462 Shares, representing approximately 57.73% of the entire issued share capital of the Company. In the event that the Directors exercise in full the power to repurchase Shares in accordance with the Repurchase Mandate, provided that the present shareholding held by Silver Rich remains unchanged, the attributable shareholding of Silver Rich will be increased to approximately 64.14%. If the Proposed Acquisition is approved by the Shareholders (other than Maruhan Corporation and its associates who are required to abstain from voting under the Listing Rules) at the SGM and the Option Completion takes place, and assuming that there is no other change in the shareholding structure of the Company, Silver Rich will hold approximately 50.84% of the entire issued share capital of the Company (as enlarged by the issue of the Consideration Shares) and its shareholding in the Company will be increased to approximately 56.49% in the event that the Directors exercise in full the power to repurchase Shares in accordance with the Repurchase Mandate. The Directors are not aware of any consequences of any repurchases of Shares pursuant to the Repurchase Mandate that would result in the Shareholder, or group of Shareholders acting in concert, becoming obliged to make a mandatory offer under Rule 26 of the Takeovers Code. In any event, the Repurchase Mandate will be exercised only if the number of Shares held by the public would not fall below 25%.
