You are entitled at any time by reasonable notice (of not less than 7 days) to the Company c/o the Branch Share Registrar in writing at the address stated above or by email at **sunevision@computershare.com.hk** to change your choice of means of receipt and/or language of the Corporate Communications. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communications by electronic means but for any reason have difficulty in receiving or gaining access to the Corporate Communications, or wish to receive printed copies, the Company will promptly upon your written request send the Corporate Communications to you in printed form free of charge.
