To make your election, please complete the Change Request Form on the reverse side and return it to the Company c/o the Branch Share Registrar within one month from the date of this letter. If you post your signed Change Request Form in Hong Kong, you may use the pre-paid mailing label at the bottom of the Change Request Form and no postage stamp is needed; otherwise, please affix an appropriate stamp. The Change Request Form may also be downloaded from the Company's website at www.sunevision.com or the website of the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the "GEM Website") at www.hkgem.com.

If the Company does not receive duly completed and signed Change Request Form from you, or does not receive a response indicating the objection from you, within one month from the date of this letter and until you inform the Company c/o the Branch Share Registrar otherwise by reasonable notice (of not less than 7 days) in writing or by email at sunevision@computershare.com.hk, you will be deemed to have consented to receiving all future Corporate Communications by electronic means through the Company's website in lieu of in printed form. A notification of publication of the Corporate Communications on the Company's website will be sent to you by post at your address as appearing in the Register.

You are entitled at any time by reasonable notice (of not less than 7 days) to the Company c/o the Branch Share Registrar in writing at the address stated above or by email at **sunevision@computershare.com.hk** to change your choice of language and/or means of receipt of the Corporate Communications. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communications by electronic means but for any reason have difficulty in receiving or gaining access to the Corporate Communications, or wish to receive printed copies, the Company will promptly upon your written request send the Corporate Communications to you in printed form free of charge.
