The board (the “**Board**”) of directors (the “**Director(s)**”) of Sunny Optical Technology (Group) Company Limited (the “**Company**”) is pleased to announce that all the resolutions as more particularly set out in the notice (the “**Notice**”) of annual general meeting (the “**AGM**”) dated 7 April 2017 were duly passed by the shareholders of the Company (the “**Shareholders**”) attending and voting at the AGM held on 26 May 2017 by way of poll.
