1. The shipment volume of handset lens sets increased by 17.0% YoY, which was mainly due to the low base caused by the weak demand from the overall smartphone market in the same period of last year; It increased by 13.2% MoM, which was mainly due to the increased customers' demands.
2. The shipment volume of vehicle lens sets increased by 14.8% YoY, which was mainly due to the increased demand from the vehicle camera market with the relief of the key components shortage in the auto supply chain.
3. The shipment volume of handset camera modules increased by 36.8% YoY, which was mainly due to the low base caused by the weak demand from the overall smartphone market in the same period of last year.
