2. The shipment volume of vehicle lens sets decreased by 35.2% MoM, which was mainly due to the impact of Spring Festival Holiday in February.
3. The shipment volume of handset camera modules increased by 72.1% YoY, which was mainly due to the low base caused by the weak demand from the overall smartphone market in the same period of last year. It decreased by 16.4% MoM, which was mainly due to the impact of Spring Festival Holiday in February.
