FURTHER UPDATE ON LEGAL PROCEEDINGS

Reference is made to the announcements (together the “**Announcements**”) dated 5 April 2012, 4 July 2012, 24 July 2012, 3 August 2012, 21 August 2012, 28 September 2012, 26 October 2012, 1 November 2012, 21 December 2012, 29 January 2013, 25 April 2013, 3 May 2013, 12 January 2015, 23 January 2015, 1 April 2015, 19 May 2015, 9 June 2015, 6 November 2015, 13 June 2016, 17 June 2016 and 7 November 2016 respectively and the sub-section headed “Litigation” in the section headed “Management Discussion and Analysis” of the annual report dated 21 March 2016 for the year ended 31 December 2015 (the “**Annual Report 2015**”) of SkyNet Group Limited (the “**Company**”) in relation to, amongst others, the legal proceedings against Mr. Shum. Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Announcements and the Annual Report 2015.

The Board announces that on 13 December 2016, a consent order was granted by the Court of Appeal of the High Court of the Hong Kong Special Administrative Region that, among others, (i) the appeal taken out by Mr. Shum by way of a notice of appeal filed on 16 June 2016 (the “**Appeal**”) be dismissed with no order as to costs; (ii) the hearing of the Appeal be vacated; and (iii) the sum of HK\$550,000 paid into Court by Mr. Shum on 3 November 2016 as security for costs of the Appeal together with the accrued interest thereon, if any, be paid out to Mr. Shum’s solicitors for receipt on behalf of Mr. Shum.
