- 2. 2,165,000 ordinary 'B' shares (repurchased during the month ended 30 June 2017) were cancelled on 7 July 2017.

1,242,500 ordinary 'B' shares were repurchased during the month ended 31 July 2017, among which 1,222,500 ordinary 'B' shares were cancelled on 14 July 2017 and 20,000 ordinary 'B' shares were cancelled on 20 July 2017.
