The Board is pleased to announce that on 11 September 2013, Inner Mongolia TCL King, a wholly owned subsidiary of the Company, entered into a Tripartite Agreement with Hohhot Auction Centre and Management Committee of Wishful Zone of Hohhot, pursuant to which Inner Mongolia TCL King agreed to sell and Hohhot Auction Centre agreed to acquire the Land Use Rights and the Buildings at a total consideration of RMB235,923,436 (equivalent to approximately HK\$296,509,000), representing the value of the Land Use Rights and the Buildings. In addition, Inner Mongolia TCL King will be entitled to a compensation and reward for its relocation from the Land in a sum of RMB61,244,000 (equivalent to approximately HK\$76,971,000) and will also be entitled to the Refund of RMB9,730,000 (equivalent to approximately HK\$12,229,000) which shall be paid by Management Committee of Wishful Zone of Hohhot. Management Committee of Wishful Zone of Hohhot also agreed to facilitate the completion of such transfer of Land Use Rights and Buildings.

As one of the applicable percentage ratios of the Disposal is more than 5% but less than 25%, the Disposal constitutes a discloseable transaction of the Company under Chapter 14 of the Listing Rules.

The Board is pleased to announce that on 11 September 2013, Inner Mongolia TCL King, a wholly owned subsidiary of the Company, entered into a Tripartite Agreement with Hohhot Auction Centre and Management Committee of Wishful Zone of Hohhot, pursuant to which Inner Mongolia TCL King agreed to sell and Hohhot Auction Centre agreed to acquire the Land Use Rights and the Buildings at a total consideration of RMB235,923,436 (equivalent to approximately HK\$296,509,000), representing the value of the Land Use Rights and the Buildings. In addition, Inner Mongolia TCL King will be entitled to a compensation and reward for its relocation from the Land in a sum of RMB61,244,000 (equivalent to approximately HK\$76,971,000) and will also be entitled to the Refund of RMB9,730,000 (equivalent to approximately HK\$12,229,000) which shall be paid by Management Committee of Wishful Zone of Hohhot. Set out below are the major terms of the Tripartite Agreement:

THE TRIPARTITE AGREEMENT

Date: 11 September 2013

Parties: (1) Inner Mongolia TCL King;

- (2) Hohhot Auction Centre; and
- (3) Management Committee of Wishful Zone of Hohhot

To the best of the Directors' knowledge, information and belief having made all reasonable enquiry, Hohhot Auction Centre and Management Committee of Wishful Zone of Hohhot and their ultimate beneficial owners are independent third parties of the Company and its connected persons.

ASSETS TO BE DISPOSED

The Land Use Rights relate to the Land owned by Inner Mongolia TCL King of approximately 102,075.79 square meters located at East of East Second Ring Road, South of Xin Hua Street, Wishful Development Zone, Hohhot. The Buildings are all the buildings erected on the Land and retained by Inner Mongolia TCL King.

CONSIDERATION AND PAYMENT TERMS

In return for the Disposal, Inner Mongolia TCL King shall receive a sum of RMB297,167,436 (equivalent to approximately HK\$373,480,000), comprising:

- 1. RMB235,923,436 (equivalent to approximately HK\$296,509,000) representing the value of the Land Use Rights and the Buildings; and
- 2. RMB61,244,000 (equivalent to approximately HK\$76,971,000) representing the compensation and reward for its relocation from the Land.

Pursuant to the Tripartite Agreement, the sum of RMB297,167,436 (equivalent to approximately HK\$373,480,000) shall be settled by Hohhot Auction Centre by two separate installments in the following manner:

- 1. First installment of RMB89,150,231 (equivalent to approximately HK\$112,044,000) shall be paid within three days upon execution of the Tripartite Agreement; and
- 2. Second installment of RMB208,017,205 (equivalent to approximately HK\$261,436,000) shall be paid within sixty days upon execution of the Tripartite Agreement.

Inner Mongolia TCL King shall provide all documents necessary for the completion of the transfer of Land Use Rights and the Buildings within ten business days after receipt of the second installment and shall vacate from the Buildings within three months after the receipt of the second installment.

The consideration was arrived at after an arm's length negotiation between the parties by reference to the average prices of similar industrial land in the neighbouring area and the prevailing market value of similar industrial lands in Hohhot. No professional valuation has been made by Inner Mongolia TCL King for the purpose of the Disposal.

In addition, Inner Mongolia TCL King will also be entitled to the Refund of RMB9,730,000 (equivalent to approximately HK\$12,229,000) which shall be paid by Management Committee of Wishful Zone of Hohhot within thirty days upon the execution of the Tripartite Agreement.

Should either party fail to complete the Disposal in the manner set out in the Tripartite Agreement, the defaulting party is liable to pay a default penalty of 5% of the value of the Land Use Rights and the Buildings to the non-defaulting party. The defaulting party is also liable to any damages suffered by the non-defaulting party which exceeds such default penalty.

OTHER MAJOR TERMS

After the completion of the transfer of Land Use Rights and the Buildings, Hohhot Auction Centre will change the land use nature of the Land from industrial use to commercial use. Inner Mongolia TCL King shall have the rights to participate in the process of bidding invitation, auction or listing of the Land and shall, subject to relevant policy, have the priority to obtain the use right of listing (掛牌使用權) of the Land.

REASONS FOR THE DISPOSAL

The Land was previously for industrial purpose and was the factory site of Inner Mongolia TCL King. The Group had already completed the construction project of new factories on another piece of land in Hohhot, the PRC to which the factories previously situated on the Land had been relocated. The Disposal will not disrupt the normal operation of the Group in Inner Mongolia.

On the Disposal, Inner Mongolia TCL King is expected to record a gain from the net sale proceeds of approximately RMB165,147,257 (equivalent to approximately HK\$207,557,000) based on:

- (i) the consideration for the value of the Land Use Rights and the Buildings of RMB235,923,436 (equivalent to approximately HK\$296,509,000);
- (ii) the compensation and reward for Inner Mongolia TCL King's relocation from the Land of RMB61,244,000 (equivalent to approximately HK\$76,971,000);
- (iii) the unaudited carrying value of the Land Use Rights and the Buildings (including all relevant costs) of approximately RMB47,421,093 (equivalent to approximately HK\$59,599,000) as at 31 August 2013;
- (iv) all expenses in relation to the Disposal amounting to approximately RMB29,550,000 (equivalent to approximately HK\$37,138,000); and
- (v) the tax payable of approximately RMB55,049,086 (equivalent to approximately HK\$69,186,000).

The Disposal is the result of the change in the government's policy in town planning and infrastructure building, which necessities the evacuation of the Group and its assets involved. The Directors considered that the Disposal represents a good opportunity for the Group to realise its assets at a reasonable price under the current market condition. The proceeds from the Disposal will provide additional cash flow, which will strengthen the financial position of the Group for its business development.

The Directors (including the independent non-executive Directors) consider that the terms of the Tripartite Agreement are fair and reasonable and in the interest of the Company and its shareholders as a whole.

The Board wishes to confirm that no Director has any material interest in the said transaction and therefore none of them is required to abstain from voting on the board resolution for approving the said transaction.

The Group, including Inner Mongolia TCL King, is principally engaged in the manufacture and sale of a wide range of electronic consumer products including television sets.
