The Board is pleased to announce that on 31 October 2018, TCL Corporation and the Company entered into the 2018 Master Services Agreement, pursuant to which relevant member(s) of TCL Electronics Group may from time to time engage relevant member(s) of TCL Corporation Group to provide TCL Corporation Group Services and relevant member(s) of TCL Corporation Group may from time to time engage relevant member(s) of TCL Electronics Group to provide TCL Electronics Group Services, subject to the terms and conditions thereof.

LISTING RULES IMPLICATIONS

TCL Corporation, the ultimate controlling Shareholder of the Company, currently holds approximately 52.89% of the total number of issued Shares of the Company, and is a connected person of the Company under the Listing Rules. Accordingly, the transactions contemplated under the 2018 Master Services Agreement constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

As one or more of the applicable percentage ratios (as defined in Rule 14.07 of the Listing Rules), other than the profits ratio, with reference to the Proposed Annual Caps (when aggregated with the amount paid or received under the Pre-Existing Transactions entered into or completed within a 12-month period) exceed 0.1% but all are less than 5%, the continuing connected transactions contemplated under the 2018 Master Services Agreement will be subject to reporting, announcement and annual review requirements but exempt from the independent shareholders' approval requirements as set out in Chapter 14A of the Listing Rules.

In their ordinary and usual course of business, member(s) of TCL Electronics Group has from time to time engaged relevant members of TCL Corporation Group to provide certain TCL Corporation Group Services, and relevant member(s) of TCL Corporation Group has from time to time engaged relevant member(s) of TCL Electronics Group to provide certain TCL Electronics Group Services (collectively "Pre-Existing Transactions") in each case by entering into individual agreement on nomral commercial terms and on arm's length basis.

In respect of TCL Electronics Group Services, the relevant TCL Electronics Group Services Fees under any Individual Agreement must be determined with reference to the prevailing market rate and in any event be not less than the rate that may be charged by TCL Electronics Group to Independent Third Parties for the provision of similar TCL Electronics Group Services.

The relevant TCL Corporation Group Services Fees and TCL Electronics Group Services Fees may be adjusted from time to time by agreement of the relevant parties in writing subject to compliance with the Listing Rules.

TCL ELECTRONICS GROUP'S PRICING POLICY AND PRICE DETERMINATION

In respect of TCL Corporation Group Services, it is the pricing policy of TCL Electronics Group that, before engaging any member(s) of TCL Corporation Group to provide the relevant TCL Corporation Group Services, TCL Electronics Group would obtain quotations for the same or similar TCL Corporation Group Services from at least two Independent Third Party service providers where possible and make an overall assessment of the terms of the TCL Corporation Group Services offered, past record of dealing with the Independent Third Party service providers (if any), payment terms, the specific requirements of a particular project, and the price quoted. TCL Electronics Group would only engage TCL Corporation Group for provision of TCL Corporation Group Services when, according to the results of the overall assessment, the terms under the Individual Agreement(s) are no less favourable in providing the relevant services than the terms offered by Independent Third Parties and that the relevant member of the TCL Corporation Group is capable of meeting the timeline, specific needs of the particular project and expected quality of the relevant TCL Corporation Group Services.
