ANNOUNCEMENT PURSUANT TO RULE 3.8 OF THE TAKEOVERS CODE

This announcement is made by TCL Electronics Holdings Limited (the “**Company**”) pursuant to Rule 3.8 of The Code on Takeovers and Mergers (the “**Takeovers Code**”).

Reference is made to (i) the announcement (the “**Announcement**”) dated 2 October 2019 jointly issued by TCL Industries Holdings Co., Ltd.* (TCL實業控股股份有限公司) (the “**Purchaser**”), T.C.L. Industries Holdings (H.K.) Limited (the “**Offeror**”) and the Company in relation to, among other matters, the mandatory unconditional general offer made by UBS AG, Hong Kong Branch on behalf of the Offeror to acquire all the issued shares in the Company (other than those already owned or agreed to be acquired by the Offeror and the Purchaser and parties acting in concert with any of them) and for the cancellation of all the outstanding share options of the Company; (ii) the announcement dated 10 October 2019 jointly issued by the Purchaser, the Offeror and the Company in relation to the update of their number of relevant securities; and (iii) the announcements of the Company dated 14 October 2019, 15 October 2019, 23 October 2019, 24 October 2019, 30 October 2019, 31 October 2019, 1 November 2019, 5 November 2019, 6 November 2019, 11 November 2019 and 12 November 2019 respectively in relation to the update of the number of relevant securities of the Company. Unless otherwise defined, terms used in this announcement shall have the same meanings as those used in the Announcement.

UPDATE OF NUMBER OF RELEVANT SECURITIES OF THE COMPANY

The Board wishes to announce that on 19 November 2019, 1,511 new Shares were allotted and issued pursuant to the exercise of 1,511 Share Options granted under the Share Option Scheme at an exercise price of HK\$3.3918 per Share.

As at 19 November 2019 (after the allotment and issuance of the Shares as described above), the Company has a total of (i) 2,362,972,379 Shares in issue; (ii) 185,263,219 outstanding Share Options; and (iii) 29,078,406 Restricted Shares. Save for the aforesaid, the Company has no other relevant securities (as defined under Note 4 to Rule 22 of the Takeovers Code) as at the date of this announcement.
