Election of Language and Means of Receipt of Corporate Communications

Otherwise, please affix an appropriate stamp. The Request Form may also be downloaded from the Company's website at <http://multimedia.tcl.com> or the website of Hong Kong Exchanges and Clearing Limited ("HKEX") at <http://www.hkexnews.hk>.

If the Company does not receive a duly completed and signed Request Form from you, or does not receive a response indicating the objection from you by 17 May 2017 and until you inform the Company c/o the Hong Kong Share Registrar otherwise by reasonable notice (of not less than 7 clean business days) in writing or by email (at tcl1070-ecom@hk.tricorglobal.com), you will be deemed to have consented to receiving all future Corporate Communications by electronic means through the Company's website in lieu of in printed form. A notification of publication of the Corporate Communications on the Company's website will be sent to you by post at your address as appearing in the Register.
