If the Company does not receive a duly completed and signed Reply Form from you, or does not receive a response indicating an objection from you by 23 October 2020, then until you inform the Company c/o the Hong Kong Share Registrar otherwise by reasonable notice (of not less than 7 clear business days) in writing or by email (tc11070-ecom@hk.tricorglobal.com), you will be deemed to have consented to receiving all future Corporate Communication(s) by electronic means through the Company’s website in lieu of in printed form. A notification of publication of the Corporate Communication(s) on the Company’s website will be sent to you by post at your address as appearing in the Register.

If you would like to change your choice of language or means of receipt of the Company's Corporate Communication(s) in future, please write or send an email to tcl1070-ecom@hk.tricorglobal.com to the Company c/o the Hong Kong Share Registrar.
