## Election of Language and Means of Receipt of Corporate Communication(s)

The notification will be sent to you by post at your address as appearing in the register of members of the Company (the "**Register**") maintained by the Company's branch share registrar and transfer office in Hong Kong, Tricor Tengis Limited (the "**Hong Kong Share Registrar**"), at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong. If you choose to receive the Corporate Communication(s) in printed form, the Company will send you printed copies of the Corporate Communication(s) in the language(s) you have expressly chosen to receive.

To make your election, please complete the enclosed reply form (the "**Reply Form**") and return it to the Company c/o the Hong Kong Share Registrar at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong by 29 May 2023. If you post your Reply Form in Hong Kong, you may use the mailing label in the Reply Form and need not affix a stamp to the envelope when returning the Reply Form. Otherwise, please affix an appropriate stamp. You may also send an email with a scanned copy of the duly completed and signed Reply Form to tcl1070-ecom@hk.tricorglobal.com. The Reply Form may also be downloaded from the Company's website at http://electronics.tcl.com or the website of HKEXnews at http://www.hkexnews.hk.

If the Company does not receive a duly completed and signed Reply Form from you, or does not receive a response indicating an objection from you by 29 May 2023, then until you inform the Company c/o the Hong Kong Share Registrar at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, otherwise by reasonable notice (of not less than 7 clear business days) in writing or by email (tcl1070-ecom@hk.tricorglobal.com), you will be deemed to have consented to receiving all future Corporate Communication(s) by electronic means through the Company's website in lieu of in printed form. A notification of publication of the Corporate Communication(s) on the Company's website will be sent to you by post at your address as appearing in the Register.

If you would like to change your choice of language and/or means of receipt of the Company's Corporate Communication(s), you have the right to do so at any time by reasonable notice (of not less than 7 clear business days) in writing to the Company c/o the Hong Kong Share Registrar at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong or by sending an email to tcl1070-ecom@hk.tricorglobal.com. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communication(s) by electronic means through the Company's website but for any reason you have difficulty in receiving or gaining access to the relevant Corporate Communication(s), the Company will promptly upon your request in writing to the Company c/o the Hong Kong Share Registrar at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, or by email to tcl1070-ecom@hk.tricorglobal.com, send the relevant Corporate Communication(s) to you in printed form free of charge.
