TCL Multimedia reports LCD TV sales of 605,024 sets in October

(November 10 2010, Hong Kong) - TCL Multimedia Technology Holdings Limited ("TCL Multimedia" or "the Group", HKSE stock code: 1070) announced its sales volume for TV and AV products in October and the first ten months of 2010.

TCL Multimedia's LCD TV sales volume for the month of October and the first ten months of this year decreased by 19.6% and 7.8%, respectively. Due to seasonal factors, LCD TV sales volume in the PRC Market decreased for the month of October by 18% YoY; however, total LCD TV sales volume for the first ten months of 2010 reached 3,850,412 sets in the region, up 13% from the same period last year. The Group's sales volume in Emerging Markets continued its high growth momentum. It saw a 234.4% YoY growth in sales volume in the first ten months of this year and a 243.3% YoY increase in October alone. LCD TV sales volume in European Markets also saw improvements, increasing by 45.6% YoY in October and 50% YoY in the first ten months of 2010 respectively. Strategic OEM business sales volume started to pick up in October following the Group's adjustment of its strategic OEM customer structure and the cooperation with Toshiba. In North American Markets, TV sales volume remained low as expected in October.

In October, LED backlight LCD TVs reached 92,534 sets, accounting for 15.3% of the Group's total LCD TV sales volume.

In the first ten months of 2010, the Group recorded AV product sales of 13,636,312 sets, down 27.1% from the same period last year.
