Mr. Li Dongsheng, Chairman of TCL Corporation, TCL Communication and TCL Multimedia, said, "In order to provide customers with innovative and high quality smartphones, smart TVs and other consumer electronics products, the Group has been actively increasing investment in R\&D and pursuing breakthroughs in product designs and technology development. We are delighted to establish a partnership with HKSTPC and set up an international R\&D base in Phase 3 of the Park. We will utilize the international and Hong Kong's resources and strengths in R\&D to further enhance our R\&D capabilities and product competitiveness. TCL will be able to gain more share of the global market for smart devices and will spare no effort to develop itself into an internationally influential global brand.

The first three buildings of Phase 3 will be fully operational in 2014, with the remaining expected to be completed in batches by 2016. Upon completion, Phase 3 will provide approximately one million square feet of gross floor area.
