This patent protects the MILWAUKEE® brand's newly introduced M12[™] and M18[™] LITHIUM-ION product lines as well as the industry's first V28[™] and V18[™] LITHIUM-ION product lines. More efficient and environmentally friendly, the Milwaukee® LITHIUM-ION technology is the result of many years of development by the company's engineers around the globe, representing a multi-million dollar investment by Milwaukee.
