He gained his Chartered Engineer status in 1992 and is a member of the Institution of Civil Engineers, United Kingdom since 1992.

Mr. Lee, as a Non-executive Director appointed by the Board to fill the casual vacancy occasioned by the resignation of Dr. Walter Kwok Ping Sheung on 27 January 2014, will hold office as Non-executive Director until the next annual general meeting of the Company to be held in May 2014. Mr. Lee will then be eligible for re-election and subject to retirement by rotation and re-election at the subsequent annual general meetings of the Company pursuant to the Company's Bye-laws. This consulting service contract can be terminated by either KMB or Mr. Lee by giving 30 days' notice.

Mr. So, aged 49, is a Group Financial Control Manager of SHKP. He is also an Executive Director of SUNeVision Holdings Limited, a Director of Route 3 (CPS) Company Limited, Transport Infrastructure Management Limited and Hung Kai Finance Company, Limited which are the subsidiaries of SHKP. From 25 February 2009 to 27 January 2014, Mr. So had served as an Alternate Director to Dr. Walter Kwok Ping Sheung, a former Non-executive Director of the Company and its subsidiary companies, KMB and LWB. Prior to joining SHKP in 2002, Mr. So worked for two banks in Hong Kong holding managerial positions in internal auditing, operation management and business planning.

Mr. So holds a Master of Business Administration degree from The Chinese University of Hong Kong and a Bachelor of Arts degree from the City University of Hong Kong. He is a member of the Hong Kong Institute of Certified Public Accountants, the Association of Chartered and Certified Accountants, the Institute of Chartered Secretaries and Administrators, the Hong Kong Institute of Chartered Secretaries, the Chartered Institute of Bankers and the Hong Kong Institute of Bankers.

Mr. So has entered into a consulting service contract with KMB for one year commencing 6 January 2014 to provide advisory services on bus service network improvement matters at a fee based on actual time incurred at a fixed hourly rate. This consulting service contract can be terminated by either KMB or Mr. So by giving 30 days' notice. As an Alternate Director, Mr. So will not be entitled to any Directors' fees for serving on the Board and Board Committees of the Company.
