About this Report 關於本報告

威高國際控股有限公司(「本公司」)發表的第四份《環境、社會及管治報告書》(「本報告」)，將繼續透過匯報本公司及其附屬公司(統稱為「本集團」)在環境、社會及管治(或「ESG」)方面的政策、措施及績效，以實現本集團的承諾，並讓各持份者瞭解本集團於ESG議題的進程和發展方向。本報告以中、英文編寫，並遵守香港聯合交易所有限公司(「聯交所」)證券上市規則附錄二十七《環境、社會及管治報告指引》(「《指引》」)的相關規定，現已上載至聯交所及本公司網站(<http://www.irasia.com/listco/hk/veeko/index/htm>)。

報告範圍

本報告聚焦本集團之化妝品和時裝業務在二零一九年四月一日至二零二零年三月三十一日(「本年度」)的營運。報告範圍則與上一財政年度一致，覆蓋香港和澳門之各零售店舖、相關辦公室及倉庫，以及位於汕頭之服裝生產廠房(統稱「各營運點」)。本報告最後一章附有完整索引，以便讀者按《指引》閱讀本報告。

確認及批准

本報告引用的所有資料均來自本集團的內部文件和統計數據。本報告已於二零二零年十月獲本集團董事會確認及批准。

The fourth Environmental, Social and Governance Report (the “Report”) published by Veeko International Holdings Limited (the “Company”) embodies the fulfilment of the commitment of the Group by continuing to report on the policies, measures and performances of the Company and its subsidiaries (collectively referred to as the “Group”) in environmental, social and governance (or “ESG”) aspects, while enabling various stakeholders to understand the progress and development direction of the Group with regard to ESG issues. This report is prepared in both Chinese and English, and complies with the relevant provisions of the Environmental, Social and Governance Reporting Guide (the “Guide”) set out in Appendix 27 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”), and has been uploaded to the website of the Stock Exchange and the Company’s website at <http://www.irasia.com/listco/hk/veeko/index/htm>.

Reporting Scope

The Report focuses on the operations of cosmetics and the fashion business segments of the Group from 1st April, 2019 to 31st March, 2020 (the “Year”). The reporting scope is the same as that of last financial year’s Report which covers the retail stores in Hong Kong and Macau, relevant offices and warehouses, as well as the garment production plants located in Shantou, of which the operations are related to the cosmetics and fashion businesses (hereinafter referred to as the “Operation Points”, and each an “Operation Point”). A complete index is enclosed in the last chapter for the reader’s easy reference to the Guide when reading the Report.

Confirmation and Approval

Information being disclosed in this Report is sourced from internal documents and statistics of the Group. The Report has been confirmed and approved by the Board of Directors of the Company in October 2020.

Environmental, Social and Governance 環境、社會及管治

環境、社會及管治管理架構

良好的企業管治及營運常規是本集團ESG發展的重要基礎，由董事會在管治架構中肩負領導角色，負責監督及檢討集團管治及營運表現。董事會亦負責確認及批核本集團ESG政策，以及ESG報告。目前，本集團已成立ESG工作小組，該小組成員來自不同部門的管理層，主要負責統籌年度ESG報告、制定相關政策及措施，並定期對績效作出檢討及向董事會匯報工作進度。

ESG Management Framework

Good corporate governance and operation practices are important foundations of the ESG development of the Group. The Board of Directors plays a leading role in governance structure and is responsible for monitoring and reviewing the governance and operation performance of the Group. The Board of Directors is also responsible for confirming and approving the Group's ESG policies and ESG reports. At present, the Group has established an ESG working group with members from the management of different departments, which is primarily responsible for coordinating the annual ESG report, formulating relevant policies and measures, conducting regular reviews of performance and reporting work progress to the Board of Directors.

環境、社會及管治風險管理

企業風險管理對本集團的日常管理程序及良好企業管治至關重要。本集團已設立及維持有效的風險管理及內部監控系統，以識別和管理業務風險。同時本公司董事會負責領導風險管理工作，並透過審核委員會評估風險管理的有效性。另外，本公司設有風險工作小組，負責檢視風險清單、制定緩解措施，以及評估風險監控的關鍵績效指標。風險工作小組每年舉行至少兩次會議，並通過審核委員會向董事會作出匯報。

ESG Risk Management

Corporate risk management is essential to the day-to-day management process and good corporate governance of the Group. The Group has established and maintained an effective risk management and internal control system to identify and manage business risks. At the same time, the Board of Directors of the Company is responsible for leading the work of risk management, and evaluates the effectiveness of risk management through the audit committee. In addition, the Company has set up a Risk Taskforce Team, which is responsible for reviewing the risk register, formulating remedial measures and evaluating key performance indicators with respect to risk monitoring. Members of the Risk Taskforce Team meet at least twice a year and report to the Board of Directors through the audit committee.

The Group understands that the existing risk management and internal control system have not covered all the ESG related issues. Going forward, the Group will continue to improve the relevant mechanisms and risk management systems for the timely identification of risks and determination of response plans in the future.



Protecting the Environment 環境保護

本集團重視業務營運對環境的影響，視其為各部門及僱員的共同責任，並致力在日常營運中實踐保護環境的理念。本集團的《環境保護政策聲明》，涵蓋本集團對排放物、資源使用，以及保護環境及天然資源的承諾及方針。同時，本集團的兩間服裝生產廠房亦設有環境保護工作小組，主要負責在生產過程中協調及落實環保措施。本集團已定期審視和更新環保政策，並設有投訴機制，回應有關環境保護的意見及建議，確保環保措施能夠有效地執行。本年度，本集團的兩間服裝生產廠房已按照《節能減排責任書》制訂節能、節水及減廢目標。

排放物

本集團於本年度繼續委託獨立專業顧問公司按照香港環保署和機電工程署編製的指引¹、中華人民共和國國家發展和改革委員會發佈的指南²，以及溫室氣體核算體系³等國際標準進行碳評估，量化其營運產生的溫室氣體排放（或稱「碳排放」）。

The Group recognizes the impact of its business operations on the environment as a shared responsibility of all departments and employees, and is committed to practicing environmental protection in its daily operations. The Group's "Environmental Protection Policy Statement" covers the Group's commitment and approach on emissions, use of resources, and protection of the environment and natural resources. At the same time, environmental protection working groups have been set up in two of the Group's two garment production plants, which are mainly responsible for coordinating and implementing environmental protection measures in the production process. The Group has regularly reviewed and updated its environmental protection policies, and has established a complaint mechanism to respond to comments and suggestions on environmental protection to ensure the effective implementation of environmental protection measures. During the Year, the two garment production plants of the Group formulated energy and water saving and waste reduction targets in accordance with the "Energy Saving and Emission Reduction Responsibility Statement".

Emissions

During the Year, the Group continued to appoint an independent professional consultancy firm to conduct carbon assessment, to quantify the greenhouse gas emissions (or "carbon emissions") produced by its operation based on Guidelines of the Environmental Protection Department and the Electrical and Mechanical Services Department of Hong Kong¹, the guidelines issued by the National Development and Reform Commission of the People's Republic of China², and international standards such as the GHG Protocol³.

Protecting the Environment (Continued) 環境保護 (續)

本年度溫室氣體排放最主要來自範圍2(能源間接溫室氣體排放)之外購能源使用，佔總溫室氣體排放的98%。本年度溫室氣體排放較上一年度減少約15%，主要原因是範圍2電力消耗所產生的溫室氣體排放減少所致。溫室氣體密度方面，香港和澳門按營業額計算的溫室氣體密度較上一年度上升38%，而廠房每千件產品產生的溫室氣體密度較上一年度增加13%。

針對溫室氣體排放的主要來源，本集團將繼續評估、紀錄及每年披露其溫室氣體排放及其他環境數據，從而檢討現行措施成效，有助日後進一步完善減排目標，提升環境績效。本報告最後一章附有索引，提供環境績效指標相關數據。

除溫室氣體外，空氣污染物主要產生於車輛燃燒化石燃料，且主要來源於香港車輛使用。

Greenhouse gas emissions for the Year derive mainly from the use of externally purchased electricity within Scope 2 (Indirect energy-based greenhouse gas emissions), representing 98% of total greenhouse gas emissions. Greenhouse gas emissions for the Year decreased by approximately 15% as compared with last year, mainly due to the decrease in greenhouse gas emissions from electricity consumption within Scope 2. For greenhouse gas intensity, the greenhouse gas intensity of our Hong Kong and Macau operations (per unit of turnover) increased by 38% as compared with the last year, while the greenhouse gas intensity per 1,000 units of products produced in our plants increased by 13% as compared with the last year.

In relation to the major sources of greenhouse gas emissions, the Group will continue to assess, record and disclose its greenhouse gas emissions and other environmental data annually, with an objective to review the effectiveness of the existing measures, which will be helpful for the further improvement of emission reduction targets and enhancement of environmental performance in the future. An index providing relevant data on environmental performance indicators is incorporated in the final chapter of this report.

In addition to greenhouse gases, air pollutants are mainly generated by fossil fuel combustion of vehicles, and are mainly derived from vehicle use in Hong Kong.

為減低日常營運對周邊環境的影響，本集團已採取不同措施，旨在減少空氣污染物及溫室氣體排放，以及管理有害及無害廢棄物。

資源使用

本集團的營運過程中使用能源、水及紙張等資源。本年度，本集團主要的能源消耗為營運中所消耗的外購電力，以及車輛消耗的汽油和柴油。本年度能源總耗量為8,616兆瓦時，其中電力消耗佔總能源消耗的96%。

Use of Resources

The Group uses resources such as energy, water and paper in its operation process. During the Year, the Group's major energy consumption was purchased electricity consumed in its operations and petrol and diesel consumed by vehicles. The total energy consumption for the Year was 8,616 MWh, of which electricity consumption accounted for 96% of the total energy consumption.

為確保在營運過程中有效及審慎地運用資源，本集團依據減少使用、重複使用及循環再造的原則，鼓勵僱員實踐節約能源、用水和紙張等措施，以減少對環境的影響。本集團在求取適用水源上沒有任何問題。

To ensure the effective and prudent use of resources in its operations process, the Group encourages its employees to put measures to conserve energy, water and paper into practice based on the principles of reduce, reuse and recycle in order to reduce the impact on the environment. The Group does not have any issue in sourcing water that is fit for purpose.

環境及天然資源

基於本集團的業務性質，本集團日常營運不涉及對環境及天然資源造成重大影響的活動。然而，本集團在作出重大商業決策時會考慮業務活動對周邊環境及氣候變化的影響。本集團的生產廠房定期識別和評估業務活動對生物多樣性和生態系統所造成的潛在影響，並採取保護水土的措施，減少日常營運對周邊環境的影響。

Environment and Natural Resources

In light of the nature of the Group's business, the Group's daily operations do not involve activities that have a significant impact on the environment and natural resources. However, the Group considers the impact of its business activities on the surrounding environment and climate change when making major business decisions. The Group's production plants regularly identify and assess the potential impacts of their business activities on biodiversity and ecosystems, and adopt measures to protect soil and water so as to reduce the impact of their daily operations on the surrounding environment.

Employment and Labour Practice 僱傭及勞工常規

本集團深信企業成功有賴僱員的共同努力及付出。本集團已制定《僱傭及勞工常規政策聲明》、以及一系列僱傭政策及措施，就有關僱傭及勞工準則、健康及安全，以及發展及培訓方面作出承諾及提供有關指引，為僱員提供健康安全的工作環境及各種職業發展的機會。

僱傭及勞工準則

為建立一個良好的工作環境及健全的僱員管理制度，本集團已制訂有關薪酬及解僱、招聘及晉升、工作時數、假期、平等機會、多元化、反歧視、其他待遇及福利方面的政策及措施，並載列在《僱員手冊》及《人事行政管理制度》中。本集團亦設有意見及投訴機制，處理和回應僱員對僱傭相關的建議及投訴。

The Group believes that the success of an enterprise depends on the joint dedication and commitment of its employees. The Group has formulated the “Employment and Labour Practice Policy Statement” and a series of employment policies and measures, making commitment and providing guidelines with regard to employment and labour standards, health and safety and development and training, and providing a healthy and safe working environment and various career development opportunities for employees.

Employment and Labour Standards

To establish a good working environment and a sound employee management system, the Group has established policies and measures relating to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination, and other benefits and welfare, which are set out in “Employee Handbook” and “Human Resources Administration Management System”. The Group has also set up an opinion and complaint mechanism to handle and respond to employment-related suggestions and complaints.

發展及培訓

本集團重視僱員的個人發展，致力為僱員提供各項培訓機會，加強僱員於市場的競爭力。本集團除了為所有新入職僱員提供基本訓練課程外，亦按各部門職能需要定期提供不同類型的內部培訓，使僱員的工作技能及專業水平不斷提升。本集團鼓勵僱員報讀外部培訓課程，亦提供學費資助（倘適用）。本集團每年進行年度工作表現評核及透過「神秘人計劃」評估店舖同事的服務質素及工作績效。此外，本集團定期檢視及更新相關措施，確保僱員掌握行業標準及趨勢，以應對未來的挑戰。

Looking forward, the Group will continue to establish a set of risk assessment procedures for the identification of health and safety risks. At the same time, the Group will regularly review and update risk assessments, and lower the level of operation risks through various risk prevention and mitigation measures.

Development and Training

The Group values the personal development of its employees and is committed to providing them with various training opportunities to enhance their competitiveness in the market. In addition to providing basic training courses for all new recruits, the Group also provides various types of in-house training on a regular basis according to the functional needs of each department to enhance employees' job skills and professional standards. The Group encourages its employees to attend external training courses and also provides tuition fee subsidy (if applicable). The Group conducts annual performance appraisals and evaluates the service quality and performance of its shop staff through the "Mystery Shoppers Programme". In addition, the Group regularly reviews and updates relevant measures to ensure that employees are aware of industry standards and trends to meet future challenges.

本集團重視供應鏈管理。本集團已制定採購程序及有關篩選、聘用、評估、管理及監察供應商的內部程序。為確保原材料供應穩定及符合質量要求及安全標準，本集團透過嚴謹的供應商評核標準，定期為供應商進行評估。本集團亦與供應商建立良好的溝通渠道，以提供適當的支援。此外，本集團設有供應鏈申訴機制，處理及回應對供應商的投訴及意見。

為減少供應鏈對環境的影響，本集團的服裝生產廠房要求供應商在提供服裝原材料及輔料時附上符合國家環保規定的合格檢測報告，確保產品符合環保要求。化妝品業務方面，自二零一八年起，本集團已落實自家品牌的生產商淘汰含有微膠珠的磨砂及清潔產品。本集團深明部分的面部清潔和磨砂產品所含有的微膠珠難以被分解，當微膠珠經排水道流入海洋，對海洋環境及生態鏈造成負面影響。

為加強供應鏈管理，本集團計劃建立風險評估流程，識別供應鏈的環境及社會風險，並制定相應政策及措施，減低供應鏈所產生的風險，在供應商採購及保護環境之間取得平衡。

The Group acknowledges that the establishment of good relationship with customers relies on quality products and services. The Group has established the “Supply Chain Management, Product Responsibility and Anti-Corruption Policy Statement” and a series of measures related to supply chain management, product responsibility and anti-corruption, so as to ensure that its operation meets industry and international standards.

Supply Chain Management

The Group places emphasis on supply chain management. The Group has established procurement procedures and internal procedures for screening, hiring, evaluating, managing and monitoring suppliers. To ensure the stable supply of raw materials and compliance with quality requirements and safety standards, the Group conducts regular evaluation of suppliers through stringent supplier assessment standards. The Group has also established good communication channels with its suppliers to provide appropriate support. In addition, the Group has a supply chain complaint mechanism in place to handle and respond to complaints and comments on suppliers.

To reduce the impact of the supply chain on the environment, the Group’s garment production plants require suppliers to provide apparel raw materials and accessories with qualified inspection reports that comply with national environmental protection requirements to ensure that the products meet environmental protection requirements. For the cosmetics business, since 2018, the Group has implemented manufacturers of products of our own brand not to use microbeads in scrub and cleaning products. The Group recognizes that microbeads in some facial cleaning and facial scrub products are difficult to decompose. When discharged into the ocean through drainage system, the microbeads will cause negative impacts on ocean environment and ecological chain.

In order to strengthen supply chain management, the Group plans to establish a risk assessment process to identify the environmental and social risks in the supply chain, and formulate corresponding policies and measures to reduce the risks arising from the supply chain and strike a balance between supplier procurement and environmental protection.
