A member entitled to attend and vote at the Meeting is entitled to appoint one or more proxies to attend, speak and vote instead of him. If more than one proxy is so appointed, the number of shares in respect of which each such proxy so appointed must be specified. A proxy need not be a member of the Company.

In the case of joint holders, the vote(s) of the senior who tenders a vote whether in person or by proxy will be accepted to the exclusion of the vote(s) of the other joint holder(s) and for this purpose seniority will be determined by the order in which the names stand in the register of members of the Company.

To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed or a notarially certified copy of such power or authority, must be deposited with the Company's branch share registrar in Hong Kong, Tricor Secretaries Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours before the time appointed for holding the Meeting or any adjournment thereof. Accordingly, this form of proxy must be delivered to the Company's branch share registrar in Hong Kong no later than 10:30 a.m. on Saturday, 9 September 2023.
- 9. Completion and delivery of this form of proxy will not preclude you from attending and voting in person at the Meeting if you so wish and, in such event, this form of proxy shall be deemed to be revoked.
