The Board wishes to inform the Members and potential investors that after preliminary assessment of the unaudited management accounts of the Group, while the Group has experienced improved operating performance as evidenced by double digit growth in its revenue and gross profit for the Year, attributable to a loss allowance made against a receivable from a project owner, which is a leading gaming operator in Macao, of approximately HK\$16,000,000 that the Group has yet to reach an agreement on its recoverability, the Group is expected to post a loss before income tax of approximately HK\$6,000,000 for the Year as compared to a net profit before income tax of HK\$773,000 for 2018.

Further details of the performance of the Group will be disclosed in the business and financial highlights announcement for the Year which will be published by the Company on 20th March 2020.
