In the case of joint holders the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s), and for the purpose seniority will be determined by the order in which the names stand in the register of members of the Company.

In order to be valid, this form of proxy and the power of attorney or other authority, if any, under which it is signed or a certified copy of such power of attorney or authority must be deposited at the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong") branch share registrar of the Company, Tricor Abacus Limited, at 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong not less than forty-eight hours before the time for holding AGM, and in default the form of proxy shall not be treated as valid.
- 8. The completion and return of the form of proxy shall not preclude you from attending and voting in person at AGM (or any adjourned meeting thereof) should you so wish.
