In order to be valid, this form of proxy and the power of attorney or other authority, if any, under which it is signed or a certified copy of such power of attorney or authority must be deposited at the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong") branch share registrar of the Company, Tricor Abacus Limited, at 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong not less than forty-eight hours before the time 7 for holding AGM, and in default the form of proxy shall not be treated as valid.

The completion and return of the form of proxy shall not preclude you from attending and voting in person at AGM (or any adjourned meeting thereof) should 8 you so wish.
