At the annual general meeting of Winox Holdings Limited (“**Company**”) held on 23 May 2016 (“**AGM**”), a poll was demanded by the Chairman of the AGM for voting on all proposed resolutions as set out in the notice of AGM dated 15 April 2016 (“**AGM Notice**”).
