POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 22 MAY 2017

At the annual general meeting of Winox Holdings Limited (“**Company**”) held on 22 May 2017 (“**AGM**”), a poll was demanded by the Chairman of the AGM for voting on all proposed resolutions as set out in the notice of the AGM dated 19 April 2017 (“**AGM Notice**”).

As at the date of the AGM, the total number of issued shares of the Company was 500,000,000 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM.
