FOR THE TWO MONTHS ENDED 28 FEBRUARY 2014

This announcement is voluntarily made pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors (the “**Board**”) of Wuzhou International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that, in February 2014, the Group achieved unaudited contracted sales of approximately RMB192 million comprising a contracted sales area of approximately 29,388 sq.m., representing an increase of approximately 17.7% and approximately 8.9% for the corresponding period in 2013, respectively. For the two months ended 28 February 2014, the Group achieved unaudited contracted sales of approximately RMB488 million comprising a contracted sales area of approximately 67,566 sq.m., representing an increase of approximately 42% and approximately 27% for the corresponding period in 2013, respectively.

The sales data disclosed above is unaudited and is based on preliminary internal information of the Group, which may be subject to change and may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. They shall not be taken as a measure or indication of the Group’s current or future operating or financial performance nor shall they be taken as a representation by the Group of the corresponding figures as may be provided in due course in the Group’s audited or unaudited consolidated financial statements.
