UNAUDITED OPERATING STATISTICS FOR THE MONTH OF OCTOBER 2014 AND FOR THE TEN MONTHS ENDED 31 OCTOBER 2014

This announcement is voluntarily made pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors (the “**Board**”) of Wuzhou International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that, in October 2014, the Group achieved unaudited contracted sales of approximately RMB732 million comprising a contracted sales area of approximately 125,398 sq.m.. For the ten months ended 31 October 2014, the Group achieved unaudited contracted sales of approximately RMB5,185 million comprising a contracted sales area of approximately 768,048 sq.m., representing an increase of approximately 28.4% and approximately 40.5% for the corresponding period in 2013, respectively.

The sales data disclosed above is unaudited and is based on preliminary internal information of the Group, which may be subject to change and may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
