This announcement is voluntarily made pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors (the “**Board**”) of Wuzhou International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that, in November 2014, the Group achieved unaudited contracted sales of approximately RMB788 million comprising a contracted sales area of approximately 117,666 sq.m.. For the eleven months ended 30 November 2014, the Group achieved unaudited contracted sales of approximately RMB5,973 million comprising a contracted sales area of approximately 885,713 sq.m., representing an increase of approximately 28.1% and approximately 43.2% for the corresponding period in 2013, respectively.

The sales data disclosed above is unaudited and is based on preliminary internal information of the Group, which may be subject to change and may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
