UNAUDITED OPERATING STATISTICS FOR THE MONTH OF APRIL 2015 AND FOR THE FOUR MONTHS ENDED 30 APRIL 2015

This announcement is voluntarily made pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors (the “**Board**”) of Wuzhou International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that, in April 2015, the Group achieved unaudited contracted sales of approximately RMB261 million comprising a contracted sales area of approximately 43,951 sq.m.. For the four months ended 30 April 2015, the Group achieved unaudited contracted sales of approximately RMB1,286 million comprising a contracted sales area of approximately 200,039 sq.m., representing an increase of approximately 14.0% and approximately 35.2% for the corresponding period in 2014, respectively.

The sales data disclosed above is unaudited and is based on preliminary internal information of the Group, which may be subject to change and may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
