UNAUDITED OPERATING STATISTICS FOR THE MONTH OF JULY 2015 AND FOR THE SEVEN MONTHS ENDED 31 JULY 2015

This announcement is voluntarily made pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors (the “**Board**”) of Wuzhou International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that, in July 2015, the Group achieved unaudited contracted sales of approximately RMB265 million comprising a contracted sales area of approximately 45,042 sq.m.. For the seven months ended 31 July 2015, the Group achieved unaudited contracted sales of approximately RMB3,543 million comprising a contracted sales area of approximately 592,492 sq.m., representing an increase of approximately 8.7% and approximately 22.5% for the corresponding period in 2014, respectively.

The sales data disclosed above is unaudited and is based on preliminary internal information of the Group, which may be subject to change and may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
