

#### **Contract Sales**

- In April 2014, the Group recorded contracted sales of approximately RMB192 million, covering a contracted sales area of approximately 24,000 sq.m.
- For the first four months of 2014, the Group recorded accumulated contracted sales of approximately RMB1,128 million and a contracted sales area of approximately 148,000 sq.m., with YoY increases of 26.8% and 18.4% respectively.
