

Contracted Sales

- In October 2014, the Group recorded contracted sales of approximately RMB732.3 million, covering a contracted sales area of approximately 125,398 sq.m., with YoY increases of 0.9% and 29% respectively.
- For the first ten months of 2014, the Group recorded accumulated contracted sales of approximately RMB5.2 billion and a contracted sales area of approximately 768,048 sq.m., with YoY increases of 28.4% and 40.5% respectively.

Land Bank

Xuzhou, Jiangsu Province

On 24 October, Wuzhou International has succeeded in the bid for the land use rights of a land parcel for warehouse logistics in Xuzhou, Jiangsu province, through a listing-for-sale process. The parcel of land is located south of Shi Dai Avenue and west of Xufeng Highway (Land Lot B of Integrated Logistics Park occupying a total site area of 210,000 sq. m. in the Quanshan Economic and Technological Development Zone). The bidding is expected to expand its integrated merchandising and logistics platform to capture business opportunities in trading, exhibition, storage and logistics.

On 28 October, Wuzhou International has signed a project investment letter of intent with the management committee of Luohuang Industrial Park in Jiangjin District, Chongqing in relation to the development of Luohuang Industrial Park. Luohuang Industrial Park is to comprise a spot trading centre for hotel supplies, construction materials, electronics and mechanical products, automobile and components as well as small merchandise items. The complex is to cover a GFA of approximately 1,000,000 sq.m.
