- In the case of joint holders of any share, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to 7. the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the Register of Members of the Company in respect of the joint holding.
- 8. The proxy need not be a member of the Company but must attend the meeting in person to represent you.
- 9. Completion and return of the form of proxy will not preclude you from attending the meeting or any adjournment thereof and voting in person if you so wish and in such event, the form of proxy will be deemed to be revoked.
