GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors (the “**Board**”) of Xtep International Holdings Limited (the “**Company**”) hereby announces that on 30 March 2010 (the “**Date of Grant**”), the Company granted to Mr. Tan Wee Seng, a non-executive director of the Company (the “**Mr. Tan**”), 600,000 share options (the “**Share Options**”) to subscribe for a total of 600,000 ordinary shares of HK\$0.01 each in the share capital of the Company (the “**Shares**”), subject to acceptance of the Grantee, under the share option scheme adopted by the Company on 7 May 2008. The granting of the Share Options to Mr. Tan was approved by all the independent non-executive directors of the Company.

Each Share Option shall entitle Mr. Tan to subscribe for one Share upon exercise of such Share Option at an exercise price of HK\$6.13 per Share, which represents the highest of (1) the nominal value of a Share; (2) the closing price of HK\$6.13 per Share as stated in the daily quotation sheets issued by the Stock Exchange on the Date of Grant; and (3) the average closing price of HK\$5.88 per Share as stated in the daily quotation sheets issued by the Stock Exchange for the five business days immediately preceding the Date of Grant.

The Share Options granted shall vest in Mr. Tan in accordance with the timetable below with a 10-year exercise period (for this purpose, the date or each such date on which the Share Options are to vest being hereinafter referred to as a “**Vesting Date**”):
