Computershare Hong Kong Investors Services Limited, the Company's branch share registrar in Hong Kong, acted as the scrutineer for the vote-taking at the AGM.

In relation to resolutions No. 2 and 3 above, the final dividend and special dividend are expected to be paid on 6 June 2018 to shareholders whose names appear on the register of members of the Company on 11 May 2018.
