The Board of the Company is pleased to announce that on 7 March, 2017, Yau Lee Wah Technology, a wholly-owned subsidiary of the Company, entered into a JV Agreement with Zhen Hua for the formation of the JV Company.

Pursuant to the JV Agreement, the JV Company shall be, after its formation, owned as to 35% by Yau Lee Wah Technology and 65% by Zhen Hua. The registered capital of the JV Company is expected to be RMB100 million. Yau Lee Wah Technology will contribute a total amount of RMB35 million, RMB23 million of which will be in the form of cash while the remaining balance of RMB12 million will be in the form of the right to use of patented technologies for manufacturing precast concrete products. Zhen Hua will contribute a total amount of RMB65 million in the form of cash.

INTRODUCTION

The Board of the Company is pleased to announce that on 7 March, 2017, Yau Lee Wah Technology, a wholly-owned subsidiary of the Company, entered into a JV Agreement with Zhen Hua for the formation of the JV Company. The JV Company will become an associate company of the Company after its formation.

THE JV AGREEMENT

The principal terms of the JV Agreement are summarized below:
