# THE JV AGREEMENT

The principal terms of the JV Agreement are summarized below:

Intended operation areas of the JV Company:

Shanghai City, PRC Jiangsu Province, PRC Zhejiang Province, PRC Guangdong Province, PRC

Parties and

shareholding ratio:

(1) Yau Lee Wah Construction (35%)

Jiangsu First Construction (65%) (2)

Total registered capital of the JV Company:

RMB100 million

Capital Contribution:

RMB100 million, to be contributed as follows:-

- 35% (amounting to RMB35 million in the form of cash) by (1) Yau Lee Wah Construction; and
