The registered capital of the JV Company is expected to be RMB100 million. Yau Lee Wah Technology will contribute a total amount of RMB35 million, RMB20 million of which will be in the form of cash while the remaining balance of RMB15 million will be in the form of the right to use of patented technologies for manufacturing precast concrete products. Jiangsu First Construction will contribute a total amount of RMB65 million in the form of cash.
