ANNOUNCEMENT PURSUANT TO RULE 3.8 OF THE TAKEOVERS CODE

This announcement is made by Yixin Group Limited (易鑫集团有限公司) (the “**Company**”) pursuant to Rule 3.8 of the Code on Takeovers and Mergers of Hong Kong (the “**Takeovers Code**”). Reference is made to (i) the pre-IPO share option scheme adopted by the Company on May 26, 2017 (the “**Pre-IPO Share Option Scheme**”), and (ii) the announcement of the Company dated September 13, 2019 in relation to, among other things, the Proposed Transaction (the “**Announcement**”). Unless otherwise defined, all capitalized terms used herein shall have the same meanings as defined in the Announcement.

UPDATE OF NUMBER OF RELEVANT SECURITIES OF THE COMPANY

The Board wishes to announce that:

- (a) on September 16, 2019, 1,133,500 new Yixin Shares were allotted and issued due to the exercise of 1,133,500 share options granted under the Pre-IPO Share Option Scheme (“**Share Options**”) at the exercise price of US\$0.0014;
- (b) on September 17, 2019, 87,500 new Yixin Shares were allotted and issued due to the exercise of 87,500 Share Options at the exercise price of US\$0.0014;
- (c) on September 18, 2019, 21,000 new Yixin Shares were allotted and issued due to the exercise of 21,000 Share Options at the exercise price of US\$0.0014; and
- (d) since the date of the Announcement, an aggregate of 217,000 Share Options at the exercise price of US\$0.0014 have lapsed pursuant to the terms of the Pre-IPO Share Option Scheme.

Details of all classes of “relevant securities” (as defined in Note 4 to Rule 22 of the Takeovers Code) issued by the Company and the numbers of such securities in issue as at the date of this announcement are as follows:

- (a) a total of 6,373,235,548 Yixin Shares of the Company are in issue; and
- (b) a total of 227,067,798 outstanding Share Options with rights to subscribe for an aggregate of 227,067,798 new Yixin Shares.

As at the date of this announcement, save as disclosed above, the Company has no outstanding securities, options, derivatives or warrants which are convertible or exchangeable into Yixin Shares and the Company has no other relevant securities (as defined in Note 4 to Rule 22 of the Takeovers Code).

DISCLOSURE OF DEALINGS

The respective associates (as defined under the Takeovers Code) of the Company and the Consortium are hereby reminded to disclose their dealings in any securities of the Company pursuant to the Takeovers Code.

In accordance with Rule 3.8 of the Takeovers Code, reproduced below is the full text of Note 11 to Rule 22 of the Takeovers Code:

“Responsibilities of stockbrokers, banks and other intermediaries

Stockbrokers, banks and others who deal in relevant securities on behalf of clients have a general duty to ensure, so far as they are able, that those clients are aware of the disclosure obligations attaching to associates of an offeror or the offeree company and other persons under Rule 22 and that those clients are willing to comply with them. Principal traders and dealers who deal directly with investors should, in appropriate cases, likewise draw attention to the relevant Rules. However, this does not apply when the total value of dealings (excluding stamp duty and commission) in any relevant security undertaken for a client during any 7 day period is less than \$1 million.

This dispensation does not alter the obligation of principals, associates and other persons themselves to initiate disclosure of their own dealings, whatever total value is involved.

Intermediaries are expected to co-operate with the Executive in its dealings enquiries. Therefore, those who deal in relevant securities should appreciate that stockbrokers and other intermediaries will supply the Executive with relevant information as to those dealings, including identities of clients, as part of that co-operation.”
