Land Acquisition and Connected Transaction

The Board is pleased to announce that pursuant to a bidding agreement between GZYG, a wholly-owned subsidiary of the Company, and SZYX in respect of the Land Parcel, GZYG paid the Deposit to the Land Bureau, and the Parties participated in, and won, the bidding of the Land Parcel on a joint basis through open tenders organized by the Transaction Center on 25 June 2013. On 25 June 2013, upon the successful bidding of the Land Parcel, the Parties entered into, in respect of the Land Parcel: (i) the Bid Confirmation with the Land Bureau; and (ii) entered into the Cooperation Agreement between themselves in respect of the establishment of the Project Company for the acquisition and development of such Land Parcel, which superseded the previous bidding agreement between the Parties.

Guangzhou Yuexiu, which indirectly holds approximately 49.7% of the total issued shares of the Company as of the date of this announcement, is a majority shareholder of the general partner of SZYX. SZYX is regarded by the Company as a connected person of the Company by virtue of its relationship with Guangzhou Yuexiu. Accordingly, the formation of joint venture between the Parties pursuant to the Cooperation Agreement and the transaction contemplated thereunder constitutes connected transaction of the Company under Chapter 14A of the Listing Rules. As each of the applicable percentage ratios in respect of such transaction is more than 0.1% but less than 5%, such transaction is subject to the reporting and announcement requirements but is exempt from the independent shareholders' approval requirement under Rule 14A.32 of the Listing Rules.

BACKGROUND

The Board is pleased to announce that pursuant to a bidding agreement between GZYG, a wholly-owned subsidiary of the Company, and SZYX in respect of the Land Parcel, GZYG paid the Deposit to the Land Bureau, and the Parties participated in,

and won, the bidding of the Land Parcel on a joint basis through open tenders organized by the Transaction Center on 25 June 2013. On 25 June 2013, upon the successful bidding of the Land Parcel, the Parties entered into, in respect of the Land Parcel: (i) the Bid Confirmation with the Land Bureau; and (ii) entered into the Cooperation Agreement between themselves in respect of the establishment of the Project Company for the acquisition and development of such Land Parcel, which superseded the previous bidding agreement between the Parties.

The Land Parcel

The Land Parcel has a site area of approximately 12,132 sq.m. and a total gross floor area of approximately 63,797 sq.m., of which the permissible gross floor area amounts to approximately 48,528 sq.m. and an underground gross floor area of approximately 15,269 sq.m.. The total land premium of the Land Parcel is RMB584,120,000 and the average land cost based on the total gross floor area amounts to approximately RMB9,200 per sq.m.. The parcel of land is for commercial use for a term of 40 years.

As of the date of this announcement, the Company's total landbank amounted to approximately 15.24 million sq.m.. In terms of the attributable interest, the Company's landbank amounted to approximately 14.27 million sq.m..

Further information about the Land Parcel

The Land Parcel is situated in Northern District, Phase One, Qianjiang New City, Jianggan District, Hangzhou City of the PRC. Some of the best riverside resources, namely the Qiantang River and the Riverside Park, rest on the south-east side of the Land Parcel and create a beautiful environment next to the Land Parcel. Moreover, the Land Parcel is close to the Hangzhou city center, which is currently undergoing large-scale redevelopments of old villages to form the Qianjiang New City that comprises of a cluster of commercial and residential buildings. The Land Parcel could be developed as commercial complexes in the Qianjiang New City and could have huge potential.

PRINCIPAL TERMS OF THE BID CONFIRMATION

On 25 June 2013, upon the successful bidding of the Land Parcel, the Parties have entered into the Bid Confirmation with the Land Bureau for the Land Parcel, the principal terms of which are as follows.

Land premium and payment

The Parties shall sign the Land Transfer Contract before 2 July 2013 with the Land Bureau. The land premium for the Land Parcel is RMB584,120,000, which shall be paid to the Land Bureau in accordance with the terms of the Land Transfer Contract.

The land premium for the Land Parcel was arrived at as a result of successful bidding of the Land Parcel by the Parties through open tenders organized by the Transaction Center after taking into account the initial bidding price required under the open tender documents for the Land Parcel, the prevailing market conditions, location of the Land Parcel and land price in the surrounding area.

PRINCIPAL TERMS OF THE COOPERATION AGREEMENT

On 25 June 2013, after the successful bidding of the Land Parcel and the signing of the Bid Confirmation, the Parties have executed the Cooperation Agreement in relation to the formation of the Project Company, the principal terms of which are as follows.

Establishment of the Project Company

According to the Cooperation Agreement, GZYG and SZYX shall establish the Project Company for the development of the Land Parcel. GZYG and SZYX shall own 20% and 80%, respectively, of the equity interest of the Project Company upon its formation. The Project Company will not become a subsidiary of the Company upon its formation. The development, management, construction, decoration, sales and operation in relation to the Land Parcel shall be conducted by the Project Company.

Term of the Project Company

The Project Company shall be established for a term of 5 years from the date of its establishment or such other period as agreed by the Parties.

Capital Commitments

The land premium for the Land Parcel in the amount of RMB584,120,000 will be financed in the following manner:

- (1) RMB50,000,000 of which shall be payable by GZYG and SZYX to the Project Company as its registered capital in proportion to their equity interest held in the Project Company (i.e. 20%:80%) before 12 July 2013; and
- (2) the balance of the land premium for the Land Parcel will be financed by way of increase of the registered capital of the Project Company payable by GZYG and SZYX to the Project Company in proportion to their equity interest held in the Project Company (i.e. 20%:80%) before 30 July 2013; and/or shareholder loan(s) to be made by SZYX to the Project Company.

The Deposit will be repaid to GZYG by the Project Company and GZYG's total contributions for the land premium for the Land Parcel will not in any event be higher than RMB116,824,000, being 20% of the land premium for the Land Parcel. GZYG's capital commitments to the Project Company will be financed by the Group's internal resources.

Compensation

Following the execution of the Land Transfer Contract but before the date of establishment of the Project Company, the defaulting Party shall pay the other Party a compensation fee of RMB67,500,000 if it fails to pay for its portion of the registered capital of the Project Company by the agreed dates for payments of such registered capital.

Management of the Project Company

The Project Company shall have five directors, one of which shall be appointed by GZYG and the remaining four directors shall be appointed by SZYX. SZYX shall appoint the chairman of the board of directors of the Project Company. The board of directors of the Project Company shall appoint the general manager and other senior staffs for the Project Company.

Board resolutions of the Project Company shall be passed by two-thirds of its directors, except that unanimous consent of all directors are required for approving the following matters for the Project Company:

• amendments of articles of association of the Project Company;

- the dissolution, de-merger and merger of the Project Company; or
- winding-up of the Project Company.

In addition to the above, the director appointed by GZYG for the Project Company shall have the veto right in respect of the board resolutions relating to the following matters for the Project Company:

- the execution of mortgages for real properties of the Project Company; or
- bank loan agreements or other financing agreements with loan amounts or principal amounts exceeding RMB50,000,000.

Matters that require unanimous approval from shareholders

The Project Company may not, without its shareholders' unanimous written consent: (i) change the nature or scope of its business, and if there are changes then they must still be consistent with the scope or purpose specified in the auction or tender document; (ii) increase or decrease the registered capital of the Project Company; (iii) change the shareholder(s) of the Project Company; (iv) distribute profits; or (v) enter into any transactions which are not on an arm's length basis.

Profit distribution arrangements

Any profits, losses and risks of the Project Company shall be shared by the Parties in proportion to their respective equity interests in the Project Company.

Call Option

SZYX has granted a Call Option to GZYG for it to acquire all of the 80% equity interests of the Project Company held by SZYX. The Call Option is exercisable by GZYG during the period commencing on the first anniversary and ending on the eighteenth month (or such extended period as agreed between the Parties in writing) from the due day for payment of registered capital into the capital account of the Project Company by SZYX. The Call Option shall be exercised at the exercise price that is equivalent to (a) the total capital contribution by SZYX (comprising the registered capital and/or shareholders loans contributed by SZYX) in the Project Company ("SZYX Contribution") plus (b) an amount equal to the SZYX Contribution multiplied by an internal rate of return of 11% per year (before tax) based on the period of time that such SZYX Contribution is contributed into the Project Company (in calculating this rate of "return", all interests accrued or paid to SZYX on its shareholders loans provided to the Project Company or any distributions or dividends payable or paid to SZYX when it is an equity holder of the Project Company shall count towards the amount of "return").

If GZYG exercises the Call Option, SZYX shall cease to be entitled to any rights or benefits nor shall it have any obligations in the Project Company from the day that the registration of the transfer of all of SZYX's equity interest in the Project Company to GZYG with the relevant administration for industry and commerce is completed.

Restrictions on transfer

Save as otherwise provided in the Cooperation Agreement, during the term of the Cooperation Agreement, the Parties shall not transfer or assign all or any part of its rights or obligations in the Project Company to a third party without the prior written consent of the other Party.

REASONS FOR AND BENEFITS OF THE TRANSACTION

The Board believes that the Land Parcel, which is close to the Hangzhou city center, will facilitate the Company to better reinforce its brand image and awareness in Hangzhou City.

The Directors (including the Independent Non-executive Directors) consider that the formation of joint venture between the Parties pursuant to the Cooperation Agreement and the transaction contemplated thereunder are conducted by the Company in its ordinary and usual course of business, and that they (including the financing and profit distribution arrangements of the Project Company) are on normal commercial terms, fair and reasonable and in the interests of the Company and its shareholders as a whole.

INFORMATION OF THE COMPANY, GZYG AND SZYX

The Company

The Company is incorporated in Hong Kong with limited liability and the shares of which are listed on the Main Board of the Stock Exchange (Stock Code: 00123) and on the SGX-ST. It is principally engaged in property development and investment, mainly focusing on properties in Guangzhou and gradually expanding into the Pearl River Delta, Yangtze River Delta, Bohai Rim Economic Zone and Central Region.

GZYG

GZYG is a wholly-owned subsidiary of the Company and is an investment holding company incorporated under the laws of the PRC.

SZYX

SZYX is a limited partnership investment fund established under the laws of the PRC. SZYX principally engages in the business of property investment and management. Guangzhou Yuexiu, which indirectly holds approximately 49.7% of the total issued shares of the Company as of the date of this announcement, is a majority shareholder of the general partner of SZYX. SZYX is regarded by the Company as a connected person of the Company by virtue of its relationship with Guangzhou Yuexiu.

IMPLICATIONS OF THE LISTING RULES

As SZYX is regarded by the Company as a connected person of the Company under the Listing Rules, the formation of joint venture between the Parties pursuant to the Cooperation Agreement and the transaction contemplated thereunder constitute connected transaction of the Company under Chapter 14A of the Listing Rules. As each of the applicable percentage ratios in respect of such transaction is more than 0.1% but less than 5%, such transaction is subject to the reporting and announcement requirements but is exempt from the independent shareholders' approval requirement under Rule 14A.32 of the Listing Rules.
