The board of directors ("**Board**") of Yuexiu Property Company Limited ("**Company**") is pleased to announce the unaudited contracted sales and preliminary sales statistics from January to May 2015 as follows:

CONTRACTED SALES FROM JANUARY TO MAY 2015 (UNAUDITED)

In May 2015, the Company's contracted sales (including contracted sales by joint venture projects) value amounted to approximately RMB2,442 million with contracted sales (including contracted sales by joint venture projects) GFA amounted to approximately 229,900 sq.m., representing year-on-year increases of 25% and 44% respectively.
