GENERAL MANDATE TO ISSUE SHARES

At the last annual general meeting of Yuexiu Property Company Limited ("Company") held on 6 June 2017 ("2017 AGM"), a general mandate was given to the directors of the Company ("Directors") to allot, issue and deal with shares of the Company ("Share(s)"). Such mandate will lapse at the conclusion of the forthcoming annual general meeting to be held on 29 May 2018 at 10:30 a.m. at Plaza I-IV, Lower Lobby, Novotel Century Hong Kong, 238 Jaffe Road, Wanchai, Hong Kong ("2018 AGM"). In order to ensure flexibility and discretion to the Directors in the event that it becomes desirable to allot or issue any Shares and grant rights to subscribe for, or to convert any security into, Shares in the Company, approval is being sought from the shareholders of the Company ("Shareholders") at the 2018 AGM to grant a general mandate unconditionally to the Directors to allot or issue new Shares and grant rights to subscribe for, or to convert any security into, Shares up to 20 per cent of the total number of Shares in issue (subject to adjustment in the case of subdivision and/or consolidation of shares) as at the date of the passing of the proposed ordinary resolution ("General Mandate") (i.e. a maximum of 2,480,261,326 Shares assuming that no further Shares are issued prior to the date of the 2018 AGM). The proposed resolution ("General Mandate Resolution") is set out as Ordinary Resolution 5B in the Notice of the 2018 AGM dated 12 April 2018 ("2018 AGM Notice"), which is set out in Appendix II to this circular.

Concerning the General Mandate Resolution, the Directors wish to state that they have no immediate plans to allot or issue any new Shares or grant any rights to subscribe for, or convert any security into, Shares. Approval is being sought from the Shareholders as a general mandate for the purposes of Section 141 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) ("Companies Ordinance") and the Listing Rules.

GENERAL MANDATE TO BUY-BACK OF SHARES

The Listing Rules permit companies with a primary listing on the Stock Exchange to buy back their own securities on the Stock Exchange, subject to certain restrictions. At the 2017 AGM, a general mandate was given to the Directors to buy back Shares. Such mandate will lapse at the conclusion of the 2018 AGM. Therefore, an ordinary resolution (as set out in Resolution 5A ("Buy-back Mandate Resolution") in the 2018 AGM Notice, which is set out in Appendix II to this circular) will be proposed to grant to the Directors an unconditional general mandate to, inter alia, buy back up to 10 per cent of the total number of Shares of the Company in issue (subject to adjustment in the case of subdivision and/or consolidation of shares) as at the date of the passing of the Buy-back Mandate Resolution ("Buy-back Mandate"). Mr. Yu Lup Fat Joseph being independent non-executive director of the Company eligible for re-election at the 2018 AGM, has made an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. Mr. Yu Lup Fat Joseph has served as independent non-executive director of the Company for more than 9 years. As an independent non-executive director, Mr. Yu has demonstrated his ability to provide objective views and exercised independent judgements in fulfilling his duties to the Company during his directorship, and he continues demonstrating a firm commitment to his roles. The Board of the Company is satisfied that the long service of Mr. Yu will not affect his exercise of

independent judgement and he will continue to maintain his independence and fulfill the important role of an independent non-executive director as required by the Listing Rules. The Board considers that the re-election of Mr. Yu as independent non-executive director is in the best interest of the Company and Shareholders as a whole, and recommends him to stand for re-election as independent non-executive director at the 2018 AGM.

ANNUAL GENERAL MEETING

The 2018 AGM Notice is set out in Appendix II to this circular.

Whether or not you are able to attend the 2018 AGM, you are requested to complete and return the enclosed form of proxy for the 2018 AGM in accordance with the instructions printed thereon to the Company's share registrar, Tricor Abacus Limited at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong, as soon as possible and in any event not less than 48 hours before the time appointed for the holding of the 2018 AGM or any adjourned meeting thereof. Completion and return of the form of proxy will not preclude you from attending and voting at the 2018 AGM or any adjournment thereof should you so wish. The form of proxy shall deem to have been revoked when you attend and vote in person at the 2018 AGM.

This explanatory statement also constitutes the memorandum as required under section 239(2) of the Companies Ordinance.

SHARES OF THE COMPANY

Whilst the Directors do not presently intend to buy back any Shares, they believe that the flexibility afforded by the proposed Buy-back Mandate would be beneficial to the Company.

It is proposed that the Directors be authorised to buy back up to 10 per cent of the total number of Shares in issue (subject to adjustment in the case of subdivision and/or consolidation of shares) at the date of the passing of the Buy-back Mandate Resolution. As at 6 April 2018, being the latest practicable date for determining such figures prior to the bulk printing of this circular ("Latest Practicable Date"), 12,401,306,631 Shares were in issue. Assuming that no further Shares are issued prior to the date of the 2018 AGM, the Directors would be authorised to buy back up to approximately 1,240,130,663 Shares during the period up to the next annual general meeting of the Company in 2019 or the expiration of the period within which the next annual general meeting of the Company is required by law to be held or the revocation or variation of the Buy-back Mandate by an ordinary resolution of the Shareholders in general meeting of the Company, whichever occurs first.

REASONS FOR BUY-BACKS

Buy-backs of Shares will only be made when the Directors believe that such a buy-back will benefit the Company and the Shareholders. Such buy-backs of Shares may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per Share.

EFFECT OF ANY BUY-BACKS

As at the Latest Practicable Date, Guangzhou Yue Xiu Holdings Limited owned approximately 49.67 per cent of the existing number of Shares of the Company. The Directors have no present intention to exercise the Buy-back Mandate to such an extent as would result in takeover obligations under the Takeovers Code.

He had been chairman of the board of directors of Guangzhou Paper Group Limited, an assistant to general manager and a deputy general manager of Guangzhou Yue Xiu Holdings Limited ("Guangzhou Yue Xiu") and Yue Xiu Enterprises (Holdings) Limited ("Yue Xiu"). Mr. Lin has relatively extensive work experience in corporate management, sound and efficient management, cost control and corporate restructuring and development and is very forward-looking and innovative in corporate operations and management. Save as disclosed above, Mr. Lin has not held any directorships in other listed public companies, the securities of which are listed in Hong Kong or overseas, in the past three years preceding the date of this circular. He is also a director of certain substantial shareholders of the Company. (formerly known as "Guangzhou Friendship Group Co., Ltd."), a company listed on the Shenzhen Stock Exchange (Stock Code: 987). Mr. Li graduated from the Faculty of Naval Architecture and Ocean Engineering of South China University of Technology majoring in naval architecture, and obtained a master of business administration degree from Jinan University. He holds the qualification of a Senior Engineer in China and the certificate in Major Administrative Decision-Making and Argumentation (廣州市重大行政決策論證專家) conferred by the Guangzhou Municipal Government. Mr. Li is entitled to receive a salary of approximately RMB1,490,000 per annum from the Company. Mr. Yu holds a master's degree in applied finance from Macquarie University in Australia and a diploma of management studies from the University of Hong Kong. Mr. Yu has over 40 years of experience in investment, banking and finance. Save as disclosed above, he has not held any directorships in other listed public companies, the securities of which are listed in Hong Kong or overseas, in the past three years preceding the date of this circular. Mr. Yu does not have any relationship with any other directors, senior management or substantial or controlling shareholders (each as defined in the Listing Rules) of the Company. Mr. Yu has a personal interest of 4,000,000 shares of the Company within the meaning of Part XV of the SFO.

There is no service contract between the Company and Mr. Yu and he will be subject to retirement by rotation and re-election at general meetings of the Company in accordance with the Articles of Association of the Company. Mr. Yu received director fee of approximately RMB321,000 for 2017.
