If we do not receive the duly completed and signed reply form by the Relevant Date, your consent shall be deemed to have been given in receiving future Corporate Communications by electronic means in lieu of the printed form unless and until you inform the Unit Registrar your choice on means of election by reasonable prior notice. A notification of publication will be sent to you by post.

If you choose to access Corporate Communications by electronic means, please provide us with your email address and we shall send you a notification by email as and when a Corporate Communication is published. If no email address is provided, we shall send you the notification by post.

You are entitled to change your choice at any time by reasonable notice in writing to the Unit Registrar either by post, by email or by fax. If you choose electronic means and, for any reason, have difficulty in receiving or gaining access to the relevant documents, we shall promptly send the printed form of the same to you free of charge upon request.

Both printed English and Chinese versions of Corporate Communications are available from Yuexiu REIT or the Unit Registrar on request, and both versions are available in an accessible format on the websites of Yuexiu REIT (for five years from the date of first publication) and HKEx news of Hong Kong Exchanges and Clearing Limited at [www.hkexnews.hk](http://www.hkexnews.hk).
